#### Attending, reporting and filming of meetings

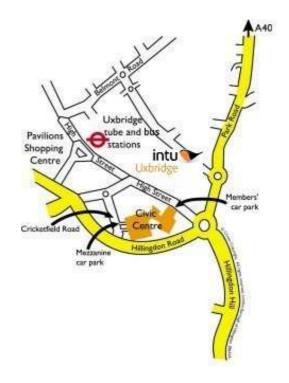

#### INFORMATION

#### Introduction

This paper presents to the Children, Young People and Learning Policy Overview Committee an update on planning for primary and secondary school places in Hillingdon.

#### Background

Demand for school places is being driven by a number of interrelated factors including birth rates, new residential developments and families moving into the Borough. Therefore, year-to-year changes in the forecast are to be expected. The forecasts are updated annually and the 2017 update was completed during the summer. However, monitoring demand for places and related analytical work takes place throughout the year, particularly following Pupil Census dates (which provide figures for the actual number of places taken up / available) and to support in-year admissions, including the placement of pupils through Fair Access mechanisms.

#### **Future Demand for School Places**

The key points from the 2017 Hillingdon forecast are as follows:

#### Primary

- The forecast confirms that the future need for primary school places in most areas of the Borough has largely been met through the comprehensive and successful primary school expansion programme and the provision of three new primary schools in the Borough.
- Overall, Reception demand is forecast to reduce slightly, reflecting a recent reduction in the birth rate. However, demand will increase in some areas, especially where there is significant housing development.

- In the north of the Borough (Northwood and Ruislip/Eastcote areas), it is expected that previous expansions and those in the pipeline (Hillside Infant and Junior schools and Warrender Primary) will provide sufficient capacity going forward.
- In the south of the Borough, some localised excess demand (around two forms of entry in total over the next five years) is forecast, particularly in the Uxbridge area. It is too early to say whether this can be managed by utilising capacity in adjacent areas that would still constitute acceptable offers in terms of home-to-school travel distances, particularly where parents seek places in the Uxbridge area but who do not live in the area. The position will be monitored closely. In the Hayes area, changes to the housing trajectory mean that a deficit is no longer forecast in the short-term. However, a caveat to this is that changes in the time scales for delivery of new housing will have potentially significant effects on the pupil forecasts for this area.

#### Secondary

- The new forecast confirms the outcome of the 2016 forecast that demand is building slightly more slowly than previously forecast.
- In the north of the Borough, ten additional forms of entry are forecast to be needed over the next five years. Plans are well underway for the expansions of Ruislip High School and Vyners and will provide three forms of entry. Proposals for two free schools were been approved some time ago and officers have been proactive in following up progress with the Education & Skills Funding Agency (ESFA). However, delivery of these places is becoming urgent and 'bulge' year groups may be needed at existing schools as an interim measure. The ESFA are currently seeking to secure suitable sites for the free schools.
- In the south of the Borough, although the Admission Number of Harlington School has reduced by one form of entry, the expansions of Oak Wood (formerly Abbotsfield) and Swakeleys schools will provide four and half forms of entry. This means that there is forecast to be sufficient places in the south of the Borough over the next two years. From 2019/20, it is expected that there will no longer be a margin of capacity and one or two additional form of entry may be needed to manage demand over the next five years. This is being kept under review.

#### Management of Demand for September 2017 Admissions

On Offer Days, all children seeking entry into Reception or into Year 7 were successfully offered places as has been the case for many years in HIllingdon. Following the start of term, actual take-up of places is now reaching a more settled state. The ESFA requested a return regarding sufficiency of places (submission deadline 13<sup>th</sup> October). Schools and academies have been contacted to obtain information on the number of vacant places in each year group.

The following tables reflect information on vacancies received from schools. Based on this, it is expected that there will be sufficient places to make offers to all pupils currently seeking a school place and a reasonable margin of capacity for future in-year applications.

One school in Primary Planning Area (PPA) 12 has not returned data and therefore the number of vacancies has been estimated based on known offers. Data returned by one school in PPA 5 is also being queried, as the number of vacant places reported is lower than expected when compared with offer data.

As can be seen, in almost every PPA, vacant places are available to accommodate in-year demand (i.e. those applications currently being processed and future applications). The main exception is PPA 13 where there are only two small schools. However, to date, it has been possible to manage demand by offering places in neighbouring PPAs. This will usually be true

of other PPAs. Otherwise, Fair Access processes are available to place pupils. In some cases, admission numbers vary between year-groups where new schools or expansions have not yet fed through into older year groups.

In relation to over-subscription, it would be very rare for a school to have no vacant places in any year groups as pupils enter and leave schools throughout the year. The best indicator is, therefore, availability of Reception places. The final column in the above table shows the number of schools in each PPA with 2 or fewer Reception vacancies out of the total number of schools with a Reception intake in that PPA.

Overall, the percentage of vacant places has increased slightly in recent years but will still be within the recommended margin once pending applications are considered.

The Rosedale Hewens Trust has advised that, as they teach by Key Stage rather than by year, they are unable to provide separate figures for Years 9 and 11.

The table above shows that in Year 7, vacancies are concentrated in a small number of schools, with most schools being full or virtually full. These figures are before taking into account applications that are being processed.

The percentage of vacant places is reducing but is still within the recommended 5-10% margin.
