Prior to the current management taking over in April 2023, the premises had its licence revoked due to serious concerns, including:</p> <ul style="list-style-type: none"> -Sales of alcohol to underage individuals -Frequent anti-social behaviour, fights, and disturbances -Significant police and council involvement <p>While the applicant claims a clean record since May 2023, residents and local stakeholders have continued to raise concerns regarding late-night disorder associated with the venue, especially in the surrounding streets. As of early 2025, it is widely believed by residents of Harlington Road and Uxbridge Road that the venue is not complying with key conditions of its current licence, specifically the requirement to operate ID scanning (face scanners) from 8pm on Fridays and Saturdays, which has not been observed in regular operation.</p> <p>The Metropolitan Police and the Council's Licensing Sub-Committee previously refused a variation application in June 2024 due to ongoing concerns about the premises' potential to generate crime and disorder. Despite proposed new conditions in this application, I do not believe insufficient evidence that robust enforcement or cultural change has taken place on-site.</p>

	<p>Given this track record and continued local unease, it is wholly inappropriate for the venue to be open until 12:30am or 1:30am, especially without meaningful compliance enforcement. A suitable timing would be in line with the Vine Pub opposite.</p> <p><u>Prevention of Public Nuisance</u> Residents have historically suffered significant noise disruption from this premises — including loud music, patrons shouting in the street, and general late-night disturbances. These issues persist and are exacerbated by the venue's proximity to residential areas.</p> <p>Noise is especially problematic after 11pm, when the surrounding streets are quieter. The presence of an outdoor garden area and recorded music intensifies this impact. Although the applicant proposes limiting outdoor use after 11pm, previous promises have not been upheld, and enforcement has been lacking.</p> <p>Additionally, public littering and loitering from patrons exiting the premises late at night continues to be an issue, affecting quality of life for nearby residents and generating more work for the Council's Street Scene Enforcement team.</p> <p><u>Public Safety</u> Given the history of fights, drunkenness, and ASB, there are public safety concerns that remain unaddressed. Although the applicant has included standard safety conditions (CCTV, staff training, emergency exits), compliance remains questionable, and trust is low in their ability to self-regulate, especially into the early hours of the morning.</p> <p>In addition, there are worries that the venue may exceed safe capacity during busy evenings, especially given its late proposed hours. Any such risk is heightened by the location's history of disorder and the previous need for police intervention.</p>

The outcome you are seeking from the Licensing Authority (See note 6);

I request that the Licensing Authority reject the variation application and instead restrict the terminal hour for licensable activity to 11pm Sunday to Thursday, and midnight on Friday and Saturday, with premises to be fully closed to the public no later than 30 minutes after these times. This will allow for winding down while preserving residents' rights to peace, safety, and quiet enjoyment of their homes.

Notes:

- 1) All representations must be submitted before the conclusion of the 28 day consultation period. This will be advertised on the public notices and also on the Councils website.
- 2) Persons who may make representation include; persons who reside near to the premises to which the application relates and who are likely to be affected by licensable activities; residents associations who are representing residents who reside near to the application premises; Ward Councillors

representing their constituents; any person who lives or works in the area and has concerns about the application premises.

- 3) Please note that representations cannot be anonymous. Copies of all representations will be published in any Committee papers and will be sent to all persons involved with the hearing including the applicant. If you have concerns about the use of your information and would like to discuss this further, please contact one of our Licensing Officers for a discussion, on the contact details below.
- 4) In order to be considered 'relevant', the representation must relate to one or more of the 'Licensing Objectives'. These objectives are;
 - a) Prevention of Crime/Disorder - This relates to any criminal activity, disorder or anti-social behaviour related to the application premises.
 - b) Prevention of Public Nuisance - This relates to noise nuisance and vibration, litter, noxious smells, light pollution.
 - c) Protection of Children from harm - This relates to the protection of children whilst on the application premises.
 - d) Public Safety - This relates to the physical condition of the premises and the safety features provided for members of the public such as; fire safety, health & safety.
- 5) Upon submitting a representation, it is expected that you will attend the Licensing Sub-Committee hearing to deliver your representation verbally and answer any queries that the Committee may have. If you are unable to attend, your written representation will be considered.
- 6) You may wish to suggest an outcome to the Licensing Sub-Committee ie. grant the application with extra conditions; grant the application with fewer hours/activities; reject the application. Please note that the Licensing Sub-Committee will only make reasonable and proportionate decisions based upon the evidence they are presented with, and in line with the laws and regulations governing Licensing Hearings.
