

I/We request the London Borough of Hillingdon to remove and dispose of non-domestic refuse arising at the address stated in 2 above and agree to pay the London Borough of Hillingdon in accordance with the Schedule of Charges annexed hereto. The London Borough of Hillingdon shall have the right to vary the charges by notice in writing not less than one month before the revised charges become effective.
5. I/We agree to pay, in advance of the service, the half yearly invoices issued by the London Borough of Hillingdon and understand that failure to do so will result in the cancellation of collections.
6. I/We understand that the amount paid in advance for any accounting period will not be subject to review up or down unless the records of the London Borough of Hillingdon show that the amount of refuse removed within the period has varied by more than 25%. Any such review will be completed by the London Borough of Hillingdon within three months of the end of any accounting period and I/we confirm that any excess due to the London Borough of Hillingdon will be paid within 28 days.
7. I/We understand that this agreement supersedes all previous agreements with effect from 1st April 1991.
8. I/We will comply with section 3 of the Health and Safety at Work etc. Act 1974 and all Regulations relating to health and safety covering the disposal of Hazardous Waste. I/We will ensure that containers deposited in the refuse are empty and that lids/caps have been removed.
9. Bulk containers (Paladins) and waste wheeler containers may be hired from the London Borough of Hillingdon. The Hire Agreement on the reverse of this form must be completed if you wish to hire such containers.
10. This agreement may be cancelled by either party at the end of any accounting period by giving the other one months notice in writing.
