This review application was supported by the Metropolitan Police Service.</p> <p>A Licensing Sub Committee was held on 17th January 2011 and having heard all relevant evidence, the decision of the sub committee was to revoke the premises licence. The premises licence holder appealed against the committee's decision and the Appeal was heard at Uxbridge Magistrates Court today, 1st August 2011.</p> <p>At the hearing, due to the information given by the appellant under cross-examination by Counsel, the District Judge stated that the appeal was doomed to fail due to the appellant's dishonesty. Therefore the Appeal was withdrawn there and then with full costs being awarded to the Council.</p> <p>The Committee congratulated all those who were involved with this case. Members specifically congratulated Licensing Service Officers, Legal Officers and Sgt Ian Meens for their hard work. Members will be aware that new powers to control Sex Establishments in Hillingdon were adopted by full Council on 12th May 2011.

A timetable for implementation was also agreed which set out the periods in which applicants could apply for Sexual Entertainment Venue Licences under the new powers.

The last date for existing premises operators to submit their applications was 23rd December 2011. We received applications from all the premises which we know provide relevant entertainment;

- The Woolpack/Inhibitions, Dawley Road, Hayes
- The Olde Northwood, Pinner Road, Northwood
- The Victoria, North Hyde Road, Hayes

No applications from new premises operators have been received however, we have received multiple enquiries from potential operators, particularly in empty shop/bar units.

The applications will need to be determined by 23rd June 2012. Sub-Committee Hearings will be arranged where necessary.

SUMMARY

To seek the views of the Licensing Committee in respect of investigation the possibilities of introducing a special gambling policy relating to the saturation of certain gambling premises in certain areas.

RECOMMENDATION

That the Committee feedback their views to the Licensing Service for further investigation.

INFORMATION

Since the introduction of the Gambling Act 2005, there has been an increase in licence applications for gambling premises in certain areas around the borough.

This has led to saturation spots where there are high numbers of gambling premises, particularly Betting Shops.

The Councils Statement of Gambling Policy is due for review over the next year, and will be implemented in 2013-2016.

The Licensing Service is minded to investigate the possibility of including a Special Policy which will aim to restrict the number of gambling establishments in certain areas.

The LGA are currently lobbying DCMS to introduce more controls to Local Councils to limit the number of premises in operation. A copy of the press release is attached.

Reckless gamble with our high streets fuelling crime

LGA media release 8 November 2011

Councils must be allowed to regain control of their high streets to stop residents being blighted by even more betting shops, council leaders said today.

Concerns have been raised by councils over the negative impact to high streets from a takeover of late night bars, off licences, fast food takeaways and bookies. However, councils lack the powers to intervene and this is causing misery for local people.

For example, on one street in Hackney alone, there are eight betting shops, which increases poverty in the community. While in Liverpool, high numbers of takeaways and drinking venues are impacting negatively on public health and crime. No powers currently exist for local people to cap the numbers of premises they haven't sought for their local area.

Complicated and costly planning rules are also stopping councils taking control of their high streets. With betting shops – councils can only act to stop them setting up by giving a years notice of plans – otherwise they may have to pay out compensation.

Cllr David Parsons, Chair of the LGA Environment and Housing Board will tell the Culture, Media and Sport (CMS) Committee today:

"The Government must give councils new powers to stop betting shops setting up if they are likely to cause a public nuisance. The same applies to places which have been taken over by fast food takeaways, strip clubs and late night bars.

"At the moment, numbers cannot be restricted and this results in crime, disorder and misery for local people. The Government should look to tackle this issue.

"Costly planning rules which are tying up councils from acting at the moment must also be addressed. These concerns are shared widely and this problem is not limited to disadvantaged areas.

"We are seeing a reckless gamble with our high streets which is contributing to higher policing and health costs, in addition to reducing the quality of life for local residents."

The comments come as the CMS Committee holds a review into the Gambling Act 2005 and its effectiveness in protecting children and vulnerable people from the adverse effects of gambling.

- Concerns about bookmakers have also been raised in the House of Commons, with Joan Ruddock MP introducing the Betting Shops Bill. This aims to create a new planning class for betting shops, making it harder for them to secure planning permission. For more information, please [click here](#)

Case studies

- **London Borough of Hackney** – Hackney has 64 betting shops which is three times the national average for a local authority area. At the same time the borough has areas of significant deprivation and a mapping of the location of these shops reveals that they cluster in the poorer areas of the borough. Another feature is that they are concentrated on particular streets with Mare St alone having eight shops and Stamford Hill with five. They are keen to tackle saturation by having new powers to consider the community impact of new premises.
- **Liverpool City Council** – Following complaints from residents, Liverpool has called for specific powers to deal with premises which materially impact upon the health and wellbeing of their local area. They make the case that too many premises serving alcohol and fast food within an area contribute towards anti-social behaviour and public health problems. In respect to licensing, they support the concept of a cap on the number of premises in each sector under the Licensing and Gaming Acts.

POLICE REFORM & SOCIAL RESPONSIBILITY ACT 2011 - UPDATE

SUMMARY

To update the Licensing Committee on the upcoming legislative changes to Licensing.

RECOMMENDATION

That the Committee note the update on new legislation

INFORMATION

The Police Reform & Social Responsibility Act received Royal Assent in September 2011.

Part 2 of the Act aims to rebalance the Licensing Act 2003 by bringing in extra controls for Licensing Authorities and at the same time, relaxing some of the more burdensome licensing systems.

Summary of changes;

Locally set fees under the Licensing Act 2003

It has long been noted that Licence fees do not cover Licensing Authorities costs of administering the Licensing Act 2003.

The Government will introduce locally set licence fees to ensure full cost recovery.

It is expected that the new system will be similar to that used for Gambling Licences in that the Government will prescribe maximum fee levels through regulations and Licensing Authorities will be able to set their fees up to that maximum.

Fees will retain the fee bands based on the premises rateable value.

Regulations are expected early next year to implement the new fees in October 2012.

Enable Licensing Authorities to suspend licences due to non payment of fees

Currently, licence holders are required to pay an annual fee for their licence. Unfortunately there is no provision to act against licence holders for non payment of fees.

The changes will enable Licensing Authorities suspend licences where payment is not made within 21 days of the fee being due.

Regulations are expected soon for implementation in April 2012.

Lowering the evidential hurdle for Cumulative Impact Policies to control outlet density

Licensing Authorities can currently limit the growth of certain types of premises in a problem area however, the evidential burden is so great that it would be extremely difficult for the authority to justify bringing in such a policy.

The amendments will enable Licensing Authorities to consider wide ranging local needs of an area and make it easier to implement such policies. The authority will have to attach greater weight to the views of local people and will not be constrained by the requirement to provide detailed additional evidence.

This change will be brought in with the revision of the Statutory Guidance under Section 182 of the Licensing Act 2003 – expected Summer 2012.

Increase the opportunities for local residents to be involved in licensing decisions – removing the ‘vicinity’ test

Currently, the only persons who may be considered ‘interested parties’ for the purpose of making representations against licence applications, are those who live in the ‘vicinity’ of the premises.

The new rules will remove the ‘vicinity’ test and instead will include ‘persons who live or have business interests within the relevant licensing authority area.’

These persons will still have to demonstrate that they are likely to be affected by the application.

Amendments are contained within the primary legislation and will be implemented in April 2012.

Reducing the burden of proof on licensing authorities

Currently Licensing Authorities have to demonstrate that licence decisions are necessary to promote the licensing objectives.

The changes will replace ‘necessary’ for ‘appropriate’ and therefore reduce the burden of proof for decisions.

Amendments are contained within the primary legislation and will be implemented in April 2012.

Making local health bodies responsible authorities

Currently, responsible authorities under the Licensing Act include; Police, Fire Service, Trading Standards, Child Protection, Environmental Health, Planning, Health & Safety.

The new legislation will make local health bodies responsible authorities. It is not yet clear who will take on this responsibility in light of the Government's plans to disband PCT's.

It is also not clear how Health Authorities will actively contribute to the licensing process as public health is not a licensing objective to which the Licensing Authority can have regard in its decision making.

Regulations are awaited.

Making Licensing Authorities responsible authorities

This is a welcome change and will mirror the system in use under the Gambling Act 2005.

This will enable Licensing Authorities to make representations against licence applications in the same way as the Police, Child Protection, Trading Standards etc.

It will also enable the Licensing Authority to call licences in for review without relying on another responsible authority.

Amendments are contained within the primary legislation and will be implemented in April 2012.

Temporary Event Notices

TEN's are currently applied for by individuals who intend to carry on licensable activities for a period not exceeding 96 hours.

There are limits imposed on the amount of TEN's an individual can serve in a calendar year, and also on the amount of days a premises may be used under a TEN.

The changes will increase the limits from 15 days to 21 days per premises and the duration from 96 hours to 168 hours.

The changes will also enable the Environmental Protection Authority to object to TEN's on the ground of public nuisance, currently only the Police may object to TEN's on crime and disorder grounds.

Applicants will also be able to serve a TEN less than 10 clear working days prior to the event under the 'late TEN's' provisions.

Regulations expected shortly for implementation April 2012.

Persistently selling alcohol to children

This offence currently carries a maximum fine of £10,000. The Government will increase this maximum to £20,000.

Amendments are contained within the primary legislation and will be implemented in April 2012.

Flexible opening hours

The introduction of 24 hour alcohol licences discouraged the use of staggered closing times, zoning and fixed closing times.

The new provisions will now encourage the use of measures to tackle problems resulting from licensed premises.

This change will be brought in with the revision of the Statutory Guidance under Section 182 of the Licensing Act 2003 – expected Summer 2012.

Licensing Policy Statement

Licensing Authorities are required to review and publish a Statement of Licensing Policy every 3 years.

The government has increased this to every 5 years.

Amendments are contained within the primary legislation and will be implemented in April 2012.

Late Night Levy

This is a new power for licensing authorities to introduce a charge for premises that have late night licences and where there are high enforcement costs for the Police and Local Authority. The levy will be set at a national level with 80% of revenue going to the Police.

Amendments are contained within the primary legislation and will be implemented in October 2012.

Early Morning Restriction Orders

EMRO's are an un-commenced power in the Licensing Act 2003 which will enable Licensing Authorities to restrict alcohol sales in certain areas between 3am and 6am if it is appropriate for the promotion of the licensing objectives.

Commencement expected October 2012.

What the changes will mean for the Licensing Authority/Licensing Service

- Public consultation on the revised licence fees and send through Committee/Cabinet/Council.
- New procedures to be devised and delegations set up for the suspension of licences following non-payment of licence fees.
- Member and staff training
- New hearing protocols to be written
- New procedures for assessing applications
- Training and guidance to be prepared for new Temporary Event Notice provisions
- The review of the Statement of Licensing Policy to include all the relevant legislation changes and policy statements.
- Extra projects, consultations, policy revisions, and PR if EMRO's, Cumulative Impact Policies and Late Night Levy's are deemed appropriate for Hillingdon.

To update the Licensing Committee on the recent reviews and Licensing Appeals

RECOMMENDATION

INFORMATION

Members will be aware of the recent reviews and subsequent appeals that have taken place over the last 12 months. Updates on the status of each premises are below;

Hayes Superstore – 75 Station Road, Hayes

- The premises Licence was revoked by the Licensing Sub-Committee on 17th January 2011 following a review application from the Trading Standards Service.
- The Licence Holder appealed the decision to the Magistrates Court and a hearing was held on 1st August 2011.
- The appeal was withdrawn by the appellant due to the inconsistency in his evidence.
- A new licence application was made for 75 Station Road by Amarjeet Singh which was granted on 1st November 2011.
- The premises continues to trade under new management.

Best Food & Wine – 61 Station Road, West Drayton

- The premises Licence was revoked by the Licensing Sub-Committee on 18th August 2011 following a review application from the Police Service.
- The Licence Holder appealed the decision to the Magistrates Court and a hearing was scheduled for 31st October 2011.
- The appeal was withdrawn at the hearing due to a new licence being granted for the premises on 21st October 2011.
- The premises continues to trade under new management.

West Drayton Food & Wine – 19 Station Road, West Drayton
