#### 6. CODE OF CONDUCT FOR MEMBERS AND CO-OPTED MEMBERS

Council, when adopting the new Code of Conduct for Members and Co-opted members in July 2012, had requested a review of the new ethical framework in 12 months time. Accordingly the Committee considered a detailed review of the way in which the new framework had operated for the last twelve months, including the revised complaints procedure. Members were satisfied that the new system was working well and that no changes were required at this time.

As a part of the review the Committee had invited applications from interested persons for the position of 'Independent Person' as defined in the Localism Act 2011. 11 such applications had been received and the Committee interviewed 10 applicants, with one applicant unable to make the interview dates of 12 and 19 June (the Committee adjourned until 19 June to make its final decision on the recommendations below).

#### 4. COMPLAINT

In particular, General Obligation 4(1) that a Member must act solely in the public interest and should never improperly confer an advantage or disadvantage on any person. Conferring an advantage includes gaining financial or other material benefits for the Member, their family, a friend or close associate.

In considering the complaint the Committee satisfied themselves that the complaint was against a Member of the Council in office at the time the complaint was made and that the Code of Conduct was in force at the time.

The Committee, after giving consideration to the views of the Independent Person, agreed unanimously that, if proven, the allegation would not represent a breach of the Code.

RESOLVED: That no further action be taken in respect of the complaint from Dr Marx against Councillor Lavery.
