An Induction Loop System is available for use in the various meeting rooms. Please contact us for further information.

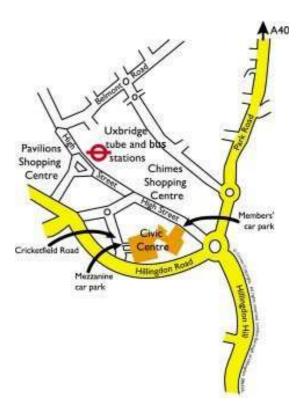
Electronic devices

7.	APOLOGIES FOR ABSENCE (Agenda Item 1)
	Apologies were received from Councillors Allen and Birah with Councillors Morse and Dhot substituting.
8.	TO AGREE THE MINUTES OF THE MEETING HELD ON 26 JUNE 2014 (Agenda Item 4)
	RESOLVED: That the minutes of the meeting held on 26 June 2014 be agreed as an accurate record.
9.	SCOPING REPORT ON DIVERSIFYING THE STREET CHAMPIONS INITIATIVE (Agenda Item 5)
	Officer provided a presentation on the proposed review which would explore diversifying and modernising the street champions initiative. The initiative was instigated in 2006 with a view to recruiting volunteers to act as the 'eyes and ears' of the Council and had grown significantly with over 4,600 volunteers. It was noted that a review of the initiative would have two main strands as set out below: 1. Developing the communications surrounding the initiative and bringing it into the 'digital age' by diversifying the ways in which volunteers could report issues and receive information. It was noted that there was scope for issues to be reported through new digital technologies rather than exclusively through the Contact Centre in order to make the initiative as accessible to as many residents as possible.
	2. Exploring how the links between street champions and Neighbourhood Watch schemes could be strengthened. Officers advised that, where street champions had grown into a successful initiative, Neighbourhood Watches in the Borough were not growing and were seen to be in need of additional support. It was proposed that this aspect of the review could supplement work already underway in a pilot project to explore how stronger links between the two schemes could be strengthened.

Officers noted that the pilot projects would be starting in September and run throughout the following year. This would mean that the Committee could receive information and intelligence gathered from the carefully selected and diverse pilot areas in order to inform this review. Specifically, this would assist with assessing the success of current communications, identifying the barriers to reporting issues and exploring how street champions could be engaged in reporting low-level crime in the Borough.

The review would also have the support of an officer working with the Hillingdon Academy as a proposal had been agreed for this to be undertaken as an Academy project.

Discussion

Members noted that, when the scheme began, volunteers were provided with feedback from the Council on the issues that they had reported. This had stopped when reporting had moved to the Contact Centre. It was suggested that a review could explore whether such automatic reporting could be re-started as it had been valued by volunteers.

With regard to witnesses, Members stated that they wished for more than 1 Street Champion to present to the Committee and suggested that there should be at least 6 volunteers invited to present evidence.

In response to Members' questions, officers advised that there would be a log of issues reported by street champions held within the Contact Centre. All residents who reported issues to the Council would be logged within Onyx meaning that they would have a unique identifier assigned to them. From this, a report could be drawn on what issues had been raised by street champions. Officers also advised that issues reported by volunteers would not be dealt with a quickly Members' Enquiries but that they would receive the same quality of service.

Members raised concerns that ward councillors were not aware either of who street champions were within their ward or what issues were being reported. It was noted that the role should not be made more onerous or bureaucratic by introducing formal reporting but that there should be a mechanism to ensure that information was passed from street champions to ward councillors. It was agreed that officers would explore whether it would be possible for ward councillors to receive a list of street champions in their wards and report back to the Committee in due course.

Officers advised that it was important that any changes to the initiative did not alienate current volunteers who may not wish to use digital technologies to report issues. Instead, the focus should be on diversifying methods of reporting to expand the demographic whilst ensuring that existing reporting mechanisms remained in place.

It was highlighted that street champions were not restricted to reporting negative issues but could also come together to bid for funding to support projects in their local areas. This would be assisted by the simplification of bidding for Chrysalis funding.

Members noted that they wished to explore whether training or inductions could be provided to volunteers and the current turnover of street champions was during the course of the review.

RESOLVED: That:

- 1. Officer explore whether the details of street champions could be passed to ward councillors and reported back in due course;
- 2. The scoping report be amended to reflect that at least 6 street champions should be invited to provide evidence to the Committee; and
- 3. The scoping report be noted.

10. **BUDGET PLANNING REPORT FOR RESIDENTS SERVICES 2015/16** (Agenda Item 6)

Officer provided a brief presentation on budget planning for Residents Services 2015/16 in which it was noted that this was one of two occasions for the Committee to discuss budget planning. The second opportunity to comment on more detailed budget planning would be in January 2015 following the announcement of the finance settlement in December 2014. Officers stated that the current pressures on budgets would be greater in the future with a further 8% of savings required and that this would make the task of managing saving more difficult. Specific pressures and uncertainties included ongoing welfare reforms and the introduction of the Better Care Fund and the Care Bill.

Officers noted that there was a savings requirement of £3,028k for the forthcoming year of which much had been banked or was on track. However, the identification of £427k of savings was still at early stages.

Officers noted that there was a £164k under spend for the services within the Committee's remit which would alleviate some of the pressures being faced.

Members thanked officers for the report and presentation. However, it was noted that they wished for the report to be more detailed and stated that it should have covered more of the information set out in the presentation.

RESOLVED: That the Budget Planning Report for Residents Services 2015/16 be noted.

11. | **FORWARD PLAN** (Agenda Item 7)

Members expressed their concerns that the report requested at the last meeting on Byelaws for Parks would be considered on the same night as it would be by Cabinet. This would mean that it would not be possible for the Committee to provide comments prior to a decision being made.

Officers noted these concerns but stressed that this was due to the Committee agreeing to move its scheduled meeting date to the same evening as Cabinet.

RESOLVED: That:

- 1. Officers request a brief outline of the changes being proposed in the Byelaws for Parks to be emailed to the Committee outside of the meeting; and
- 2. The Forward Plan be noted.

12. **WORK PROGRAMME** (Agenda Item 8)

Officers advised that a paper had been produced and considered by the Committee on road safety around schools in 2011. If this provided Members with enough information on the matter, the report requested at the last meeting would be removed from the

work programme. If more information was required, it was requested that Members provide an additional steer as to what further information was being sought.

RESOLVED: That:

1. Officers circulate the paper produced in 2011 on road safety surrounding schools;
2. the Work Programme be noted.

The meeting, which commenced at 5.30 pm, closed at 6.35 pm.

INFORMATION

On 30 July 2014 Members agreed that the first major review of this municipal year would focus on the role of the Borough's street champions. It was decided that the review would also explore ways in which the Street Champions initiative could be better linked with the Borough's Neighbourhood Watch Schemes.

For this review witness sessions will be divided into two sections. The first sections (starting at 5.30pm) will be with 2 active street champions who have volunteered to provide evidence to the Committee. Over the 3 witness sessions, this will mean that Members will hear from a total of 6 Street Champions from across the Borough. Once Members have heard from these volunteers they will be allowed to leave the session before the second section in which other witnesses will be present to provide evidence.

Review Terms of Reference Written Submission - Community Safety & CCTV Manager

Terms of Reference

Setting the context

- 1. To gain a comprehensive understanding of the current Street Champions initiative to include:
 - a. The current level of uptake across different areas of the Borough;
 - b. The volume and nature of the issues raised;
 - c. The remit and accountability of the role; and
 - d. The barriers to involvement and reporting issues.
- 2. To gain a comprehensive understanding of the Neighbourhood Watch Scheme to include:
 - a. The findings of the pilot project into linking the Street Champions Initiative and the Borough's Neighbourhood Watch Scheme;
 - b. The current level of uptake across different areas of the Borough;
 - c. A clear idea as to where schemes are located in the Borough; and
 - d. The barriers to involvement.

Better Access and Reporting

- 1. To explore ways in which the Council could better use its current resources (e.g. its website) to increase the ease with which volunteers are able to report issues;
- 2. To assess the viability of using new forms of digital media in order to make reporting issues more accessible; and
- 3. To explore ways in which those volunteers who do not wish to use digital medias can better report issues.

Street Champions and Neighbourhood Watch

- 1. To put forward recommendations on how the Street Champions initiative could be linked with Neighbourhood Watch Schemes in the Borough;
- 2. To explore ways in which Street Champions could be encouraged to engage more generally in the community safety agenda; and
- 3. To explore how these initiatives might be linked through the use of the technologies highlighted above.

DIVERSIFYING THE STREET CHAMPIONS INITIATIVE – WRITTEN SUBMISSION

Name: Liz Jones

Role: Community Safety Manager

Organisation: London Borough of Hillingdon

CONTEXT

The London Borough of Hillingdon's Community Safety Team contributes £5,000 (2014/15) towards the running of the Borough's Neighbourhood Watch scheme. This year this funding is dependent upon Neighbourhood Watch setting up new Watches in areas of high need (long-term crime hotspots).

Hillingdon Neighbourhood Watch plays a role in our community engagement strategy. It is possible to use the Neighbourhood Watch network to gather information about crime and disorder priorities and to distribute "slow time" messages about seasonal crime prevention hints and tips for residents.

Hillingdon Neighbourhood Watch is an independent organisation that receives support either in cash (from the London Borough of Hillingdon) or in kind (use of Ruislip Police station from the police). There is a small Board made up entirely of volunteers. The Board is responsible for distributing a regular newsletter to individual, active Watches across Hillingdon and for managing a local Neighbourhood Watch website.

Individual Neighbourhood Watches do not need to be "endorsed" by the Board to be effective, or to be "allowed" to set up. It may well be the case that many Watches are active without the knowledge of the Board.

GAPS / CHALLENEGES

There are currently no formal, direct links between the Street Champions scheme and Hillingdon Neighbourhood Watch.

There are three main challenges facing Hillingdon Neighbourhood Watch:

- Difficulty getting Neighbourhood Watch scheme set up in the south of the Borough, often in areas of high crime. These communities are generally very challenging to work in as there is often a high turnover of residents due to the high proportion of private rented housing stock, plus a high proportion of recent arrival communities who do not have English as a first language.
- Difficulty getting residents to volunteer to sit on the Board of Neighbourhood Watch.
 The current Board is very small (only 4 or 5 members) and this presents a challenge when asking NHW to commit resources it doesn't easily have access to.
- Communication to Watch members. The primary media for communication with Watch members is via a printed newsletter. This does not allow for fast time communication, is costly (in terms of money and time) to produce and distribute and gives an impression of an organisation "out out touch" with modern communication methods using social media.

IMPROVEMENTS AND WORK FOR THE FUTURE

Community development and engagement with residents in the south of the Borough, especially those in long-term crime hotspots would be beneficial to encourage residents to take steps to keep themselves safe (e.g better home security, supporting and assisting more vulnerable members of their community). However, this is very resource intensive in terms of staff input and would be difficult to deliver within current resource levels.

Links to other community engagement groups such as police Ward Panels (which are currently being reviewed) may identify willing individuals who would want to play a role in Street Champions and/or Neighbourhood Watch.

Use of social media and digital communication may help to interest younger people in becoming active members of any group, including Neighbourhood Watch. Whilst relying totally on new media could isolate current, older active members there is a risk that by relying so heavily on traditional communication Neighbourhood Watch does not attract a new generation of participants.
