Attending, reporting and filming of meetings

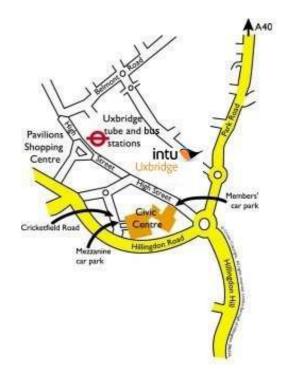

51. APOLOGIES FOR ABSENCE

Apologies for absence was received from Councillor Mills and Councillor East, with Councillor Ahmad-Wallana substituting.

52. DECLARATIONS OF INTEREST

There were no declarations of interest.

53. MINUTES OF THE MEETING HELD ON 4 JANUARY 2018

RESOLVED: That the minutes of the meeting held on 4 January 2018 were agreed as a correct record.

It was agreed that all items would be considered in public.



55. DRAFT BUDGET PROPOSALS 2018/19 - COMMENTS FROM POLICY OVERVIEW COMMITTEES

The Committee received the comments from Policy Overview Committees on the Cabinet's draft budget proposals for 2018/19.

The Labour Group noted the comments from the Labour Members on the budget proposals that were included in the minutes of the four Policy Overview Committees, attached as an appendix to the report.

Members agreed to note the budget and forward it to Cabinet for approval.

RESOLVED: The Committee noted the budget proposals and submitted the agreed set of comments to Cabinet for consideration.

56. RESIDENT ENGAGEMENT IN DEMOCRACY: UPDATE ON THE COUNCIL'S YOUTUBE LIVE BROADCASTING OF COUNCIL MEETINGS

The report introduced by the Democratic Services Officer outlined the background to the Council's Youtube broadcasting of council meetings and feedback from residents in relation to meetings that were attended or watched online.

Members heard that the viewing of council meetings online compares favourably with the few other local authorities that also do this within the UK, with over 25,000 people having watched meetings online since broadcasts began in 2016. The Committee was also informed that resident feedback was overall positive, with 81% satisfied.

Members noted that the satisfaction at Planning Committees was lower than other meetings, and heard that in some cases this was due to the respondent being unhappy with the decision made at the meeting, as opposed to the meeting process.

It was noted that satisfaction at Planning Committees may also improve if the maps and plans were made more visible on the screens, and the quality of photos taken by officers was improved. Members requested that this information was relayed to the Planning Department.

Responding to Members' questioning, the Democratic Services Officer confirmed that Petition Hearings were not usually recorded on Youtube, although if a hearing was held regarding a high-profile petition that had attractive a number of signatures, then it was possible to broadcast the meeting. It was noted that broadcasting equipment was only available in the Council Chamber and Committee Rooms 5 and 6.

Councillors asked whether a breakdown of the 25,000 views could be achieved to find out how many viewers were residents of Hillingdon, and questioned whether it would be possible to subtitle broadcasts or look into transcriptions to ensure that the broadcasts were accessible for deaf residents.

The Committee thanked the Democratic Services Manager for the quality of the report, and noted that the content was very interesting.

RESOLVED: That the report regarding Resident Engagement in Democracy was noted.

57. 'HOMOPHOBIC, BIPHOBIC AND TRANSPHOBIC BULLYING' REVIEW -RECOMMENDATIONS

Members considered the draft recommendations that were to be included in the Committee's review regarding Homophobic, Biphobic and Transphobic Bullying, and noted that they wanted to ensure the recommendations were as strong as possible.

It was agreed that a further recommendation be included to ensure the Council put out a press statement celebrating LGBT awareness on the occasion of the London Pride festival, and fly the rainbow flag outside the Council on this date. Members noted that it was vital the Council led by example and action that was supportive of the LGBT community would send an important message to the rest of the community.

Members also agreed that the wording of recommendation four be changed to state that "The Committee recommend that the Council becomes a 'Stonewall Diversity Champion'".

The Committee also noted that the review should be publicised in the Hillingdon People magazine, with comments from both the Chairman of the Committee and Labour Lead Member, to advertise the review.

RESOLVED: Members agreed to publicise the final report into homophobic, biphobic and transphobic bullying in the Hillingdon People magazine, and confirmed the recommendations for the review, subject to the following changes:

- 1. The addition of a recommendation which ensures the Council put out a press statement and fly the rainbow flag outside the Council on the date on London Pride to celebrate LGBT awareness; and
- 2. That recommendation four be reworded to state that "the Committee recommend that the Council becomes a Stonewall Diversity Champion".

VOLUNTEERING IN HILLINGDON

REASON FOR ITEM

At the Committee meeting on 11 April 2017, it was suggested that a review take place into Volunteering in Hillingdon. Following advice from Officers, Members agreed that a different topic was more suitable for a review, but requested an update on the topic in the absence of a review.

RECOMMENDATION

That the Committee noted the report on Volunteering in Hillingdon.

BACKGROUND

What do we mean by Volunteering?

Volunteering takes many forms across all communities, all sectors and all parts of our Borough. It is driven by a desire on behalf of individuals to help and support others, to seek and influence change, through pride and/or concern for our community and environment, or to pick up skills and experience and to enjoy sport, leisure and culture.

Common themes that mark out volunteers are a selfless commitment towards helping others for no financial reward or personal benefit other than perhaps satisfaction, learning and enjoyment.

The term "Social Capital" was developed about 20 years ago to describe the glue that bonds communities together through the networks, groups and relationships. Volunteering is at the heart of effective Social Capital.

Volunteering in Hillingdon

Hillingdon is home to a vibrant and diverse voluntary and community sector (VCS or third sector), consisting of more formal and well-known charities, to sport, youth and uniformed groups, faith groups, resident and community associations, through to very informal sometimes ephemeral groups and networks.

All of these groups will rely on volunteers to provide governance as trustees, to lead and manage organisations and to deliver functions and services to residents around Hillingdon. Many will consider themselves as getting involved as and when to help out rather than as any formal role. Many of our VCS groups would struggle without the regular throughput and commitment of keen and able volunteers.

In addition, employers may consider supporting volunteers from outside their workforce to gain experience or skills, or from within their workforce to encourage philanthropy and to support projects or groups.

The significant student population at Brunel University and at Uxbridge College is actively involved in volunteering, with students being encouraged to support a number of activities and initiatives and make a valuable contribution to the local community. Brunel holds an annual awards dinner for its students, in order to recognise their efforts and celebrate with local partners in order to strengthen the relationship with the wider community.

Hillingdon Council Supporting and Encouraging Volunteering

Hillingdon Council provides nearly £2m though a **programme of core grants** to 38 groups, designed to enable them to meet some of their central core costs and to provide capacity so that they may generate further investment and promote volunteering. They range from well-known groups such as Age UK Hillingdon, Hillingdon Carers, Citizens Advice Bureau, Hillingdon MIND and Disability Association of Hillingdon (DASH), through to smaller groups such as the Pinner and Ruislip Beekeepers Association. Each of these groups depends heavily on volunteers to deliver their services and the Council-core grant enables them to support and develop their volunteering offer.

Recycle-a-Bike (RAB) is a **social enterprise based** in Fassnidge Park Uxbridge. RAB offers **volunteering opportunities** including training to residents who experience mental health problems. Opportunities exist in both their bike workshop and in the park cafeteria. Many participants have moved into paid employment after they have gained skills and confidence at RAB. The Council supports the operations via a small voluntary sector grant.

Through the **Leader's Older Peoples Initiative**, voluntary groups are encouraged to provide activities and events for older people in our communities, offering opportunities to promote wellbeing and to reduce loneliness. Last year, over 44 individual grants were awarded to groups. The Council also provides grants to support older peoples dining centres.

The Council, through the work of its Strong and Active Communities Partnership, recognises that volunteering plays an important role in **building strong and cohesive communities**, bringing people together and building social capital. From schools to faith communities to the fire/police service the partnership identifies opportunities to collaborate together and engage local people in local projects and initiatives. Supported by the Mayor of Hillingdon, the partnership has delivered an **annual Volunteer Awards** ceremony, gaining sponsorship from local businesses, to recognise and thank the variety of volunteers across the borough.

The Council is also **promotes and encourages volunteering via its Hillingdon People** residents magazine and use of website and social media. Hillingdon People has dedicated pages to volunteer stories and opportunities. The Council website provides a number of links to volunteering opportunities with established local charities and groups, including in parks and gardens, as well as residents associations and community centres.

Hillingdon Council also has in place **policies to enable volunteering**, where appropriate, within and alongside its services. Guidance sets out the process officers should consider when seeking to recruit a volunteer, including ensuring that volunteers do not replace paid staff. Whilst processes are in place, in practice, it is mostly front-line services where volunteers can contribute, for example libraries, youth centres, and the new WWII bunker visitors centre etc.

How to Volunteer

The simplest way to find an opportunity to volunteer is to log onto the Do-it.org website, which is set up to broker opportunities between those seeking to volunteer and opportunities that exist locally. On 21 February 2018, there were 167 opportunities within 5 miles of Uxbridge, 970 within 10 miles, and 5,181 within 20 miles. Local groups were seeking volunteers for office support/receptionist roles, charity shop assistants, social media support, listening volunteers, trustees and volunteer drivers, amongst many others.

In addition, the H4All voluntary sector consortium (consisting of AgeUKH, Hillingdon Carers, MIND, DASH and Harlington Hospice) has established its own volunteering hub to co-ordinate its efforts in recruiting and supporting volunteers (see: <u>http://www.h4all.org.uk/volunteer-hub</u>).

Brunel University also brokers and develops volunteering opportunities for its student base (see http://brunelvolunteers.com/), and Uxbridge College offers similar support.

Data on Volunteering

There is a lack of good quality data on local volunteering. The only meaningful way to obtain data would be via a representative survey. There are some, rather out of date, surveys we can consider to give some sort of local picture:

- The Taking Part Survey, conducted by DCMS and published via the GLA data store, sets volunteering in Hillingdon at 24% of the adult (16+) population based on a three- year average between 2010/2011 and 2012/2013;
- The former Place Survey, last undertaken in 2008, put adult volunteering in Hillingdon at 21.8%;
- A Cabinet Office Community Life Survey 2015-2016 sought data through surveys on formal, informal and overall volunteering (adults at least once a year). This set a national percentage figure at 70% for overall (60% informal and 41% formal), though the survey also shows that number would be lower for London at 54%. The survey does not break down to borough level.
- The last Sport England active people survey in 2014, identified that some 15% of the population in Hillingdon had volunteered in sport.
- Our 38 core grant recipients reported that they benefitted in total from involvement of some 1,360 volunteers in 2017/18.

REASON FOR ITEM

This item is to provide an update on how the review into 'Homophobic, Biphobic and Transphobic Bullying' (HBT) in the Borough has been progressed since the last meeting.

OPTIONS OPEN TO THE COMMITTEE

The Committee is asked to note the update on the review and agree to delegated authority to the Chairman of the Committee, Labour Lead Member and Democratic Services Officer to circulate a final copy of the report to Committee members, agree the final draft of the report, and schedule the review to be presented to a future Cabinet meeting.

BACKGROUND

- At the previous meeting of the Committee, the draft recommendations for the review were confirmed by Members. Following this meeting, the Chairman of the Committee and the Chairman of the Children, Young People and Learning Policy Overview Committee, met with a number of young people who attend the Fountain's Mill LGBT Youth Group.
- At this meeting, a number of points and suggestions were raised, which are summarised below:
 - Teachers must be better educated on the issues of HBT bullying.
 - General anti-bullying campaigns have not had much impact; schools need to be handson and approach the problems directly. Educating the bullies themselves was vital towards any success.
 - Students must be educated about homophobic language. HBT language is normalized, and is painful to hear. Improved Communications and awareness of this should be considered.
 - HBT language could be included in any guidance / templates that are issues to schools to tackle HTB bullying.
 - An LGBT Youth Group that was activity-based might be a popular idea. It would not just be somewhere to sit and talk, but to interact and engage in activities (such as sport). This would likely be more popular among LGBT youths, and might increase attendance at these groups.
 - Groups outside school would also be beneficial. Currently there are a number of events in/after schools, but nothing provided for weekends.
 - The Council could consider looking into so-called "safe havens" from bullying for people who felt under threat, similarly to the "Ask Angela" campaign that was aimed at protecting people who did not feel safe on a date. It was suggested that libraries could be used for this.

Corporate Services & Partnerships Policy Overview Committee - 7 March 2018

- More LGBT information should be put on the relevant websites; e.g. the Young Hillingdon website. Information on youth groups and advice, or links to other websites that provide advice, would be supported.
- The Youth Council might have some useful input to the review to open up more ideas and concepts.
- The Youth Group was very supportive of the idea of flying the Rainbow flag on the day of London Pride. It was noted that this took place in Harrow, and it was a nice gesture to the LGBT community that made them feel valued and supported.
- It was suggested that a LGBT-friendly event might be popular among LGBT youths. Suggestions for the event included sessions on the history of LGBT issues, role models, and breakout sessions to discuss experiences and support structures, with involvement from guest speakers, companies who were interested in supporting LGBT issues and Stonewall.
