### **17. APOLOGIES FOR ABSENCE**

Apologies were received from Councillors Dominic Gilham, Janet Gardner, Lynne Allen and Jazz Dhillon.

### **18. DECLARATIONS OF INTEREST IN MATTERS COMING BEFORE THIS MEETING**

No interests were declared by Members present.

### **19. TO AGREE THE MINUTES OF THE MEETING HELD ON 17 OCTOBER 2017**

The minutes of the last meeting were agreed as a correct record.

### **20. TO CONFIRM THE ITEMS OF BUSINESS IN PART 1 WILL BE CONSIDERED IN PUBLIC AND ITEMS MARKED PART 2, IN PRIVATE**

It was confirmed that the business marked public and private would be considered as set out on the agenda.

### **21. LICENSING ACT 2003 - RESPONSE TO THE HOUSE OF LORDS SELECT COMMITTEE REVIEW**

The Committee received an update on the review of the Licensing Act 2003 by a House of Lords Select Committee. It was noted that the Government had published their response which had been summarised by officers.

Members made the following key points:

- They welcomed the Government's rejection of the proposal to merge licensing functions with planning committees.
- Concerns were expressed over the impact over any changes of responsibility for licenced premises air-side at Heathrow airport, which was currently not a Council function.

- Understanding there was currently no “late night levy” on relevant licensed premises in Hillingdon, Members sought assurances on how the night time economy was policed and considered whether such a levy may need to be reviewed in the future.

**RESOLVED: That the Government’s response be noted.**

**22. GAMBLING ACT 2005 - CONSULTATION ON PROPOSALS FOR CHANGES TO GAMING MACHINES AND SOCIAL RESPONSIBILITY MEASURES**

Members were aware of the recent Government consultation on proposed changes related to gaming machines and gambling social responsibility. The Committee had previously supported efforts by the Government to reduce the maximum stake on all Fixed Odd Betting Terminal machines.

Whilst welcoming the Cabinet Member’s response on behalf of the Council to the Government’s consultation, there was a consensus amongst Members that the Committee should have been engaged in the process beforehand.

**RESOLVED: That the Committee note the Council’s response.**

**23. TACKLING STREET DRINKING AND RELATED ANTI-SOCIAL BEHAVIOUR (VERBAL UPDATE)**

An officer from the Anti-Social Behaviour & Environment Team attended to give an update to Members on actions and enforcement that the Council, with the Police, were undertaking to tackle ASB related to alcohol use, licensed premises and off-licences.

Street drinking hotspots had been identified with Fixed Penalty Notices being issued. Proactive work was also being undertaken by the Council and Police with premises when they plan for particular events.

Some Members mentioned the use of new cigarette columns, which had successfully reduced litter outside one particular underground station. Importantly, Members were of the view that a zero tolerance approach should be undertaken. They encouraged officers to further challenge transgressions by street traders onto the highway and better target specific areas. Members also sought more statistical data and trends on joint enforcement activity.

**RESOLVED: That the Committee note the update provided and request officers, with the Police, provide to a subsequent meeting a set of informative Borough-wide statistics and trends covering all Police and ASB licensing, street trading and street drinking related offences.**

## **24. LEGISLATIVE AND INDUSTRY UPDATE**

The Committee's legal advisor briefed Members on the recent case law in relation to the Scotch Whisky Association's (and others) recent challenge against minimum alcohol pricing in Scotland. Additionally, useful updates were given on the new Gambling Commission Strategy and recent measures implemented to tackle gambling advertising that appeals to children.

**RESOLVED: That the Committee note the information.**

### INFORMATION

#### Terms of Reference

The Committee's Terms of Reference is set out below. This also provides the framework for which licensing related decisions are taken by the Sub-Committees and Officers.

#### **(a) Introduction**

*The Committee discharges the Council's functions under the Licensing Act 2003, Gambling Act 2005, Sex Establishment Venue Licences under the Local Government (Miscellaneous Provisions) Act 1982, Street Trading determination functions under the London Local Authorities Act 1990 and the Scrap Metal Dealers Act 2013, which are statutory in nature.*

#### **(b) Membership**

*The Committee will have 10 Members (10 is the minimum required under regulations). Political balance rules do not apply to the make-up of the*

*Committee. The Licensing Committee will meet on a regular basis and the Licensing sub-committees will meet on a programmed basis to effectively discharge its functions.*

*There will be a single Licensing Sub-Committee which will comprise 3 Members of the Licensing Committee selected on a rota basis, with any substitute Members, if required, being selected from the Licensing Committee only. The meetings of the Sub-Committee will be chaired by either the Chairman or Vice-Chairman of the Licensing Committee. Political balance rules do not apply to the make-up of the Sub-Committee. The Sub-Committee will determine all agreed delegated licensing functions.*

**(c) Terms of Reference**

- 1. To oversee the discharge of all licensing functions of the Council as the licensing authority under the Licensing Act 2003, Gambling Act 2005, Local Government (Miscellaneous Provisions) Act 1982, London Local Authorities Act 1990; the Scrap Metal Dealers Act 2013 and The Police Reform & Social Responsibility Act 2011, except, in respect of each, the determination of the Council's Statement of Licensing Policy and the publication of that Statement.*
- 2. To establish and appoint sub-committees to determine any applications requiring a hearing under the Licensing Act 2003, Gambling Act 2005, Local Government (Miscellaneous Provisions) Act 1982, London Local Authorities Act 1990 and the Scrap Metal Dealers Act 2013 or otherwise the determination of any application not delegated to officers.*
- 3. To arrange for the discharge of the functions governed by the Licensing Act 2003, Gambling Act 2005, Local Government (Miscellaneous Provisions) Act 1982, London Local Authorities Act 1990 and the Scrap Metal Dealers Act 2013 by its sub-committees or by officers except where prohibited by the Licensing Act 2003 and Gambling Act 2005*
- 4. To receive and consider reports, where appropriate, on the needs of the local tourist economy, employment and investment in the area and any other matter directly related to the licensing functions in the Borough.*

**Delegations**

Appendix 1 shows the current Officer and Member-level delegations for licensing decisions. These have been in place for a number of years and show what decisions are delegated to the sub-committees and what decisions are delegated to officers to take. This provides for flexible and responsive decision-making, whilst also ensuring Members take the more significant, contested licensing decisions. Additionally, Members should note that Full Council on 7 September 2017 agreed a new provision to enable ward councillors, with reasons and within the consultation period, to ask that an application under the Licensing and Gambling Acts be called directly into a Licensing Sub-Committee for determination - rather than determined officers. The same provision exists for planning applications to Planning Committees.

### **Licensing related policies**

The Council is required to have key licensing policies in places, which require either Cabinet or Full Council approval. The Licensing Committee is a key consultee on these, prior to final decision. Appendix 2 shows the timetable for policy reviews for Members' information.

### **Home Office returns**

Each year, the Council is required to submit a statutory return to the Home Office which details all the licensed premises under the Licensing Act 2003 that have permission for alcohol, entertainment and/or late night refreshment. A copy of the 2018 return is provided as Appendix 3, for general information that Members may find useful.

### HEADLINES

This procedure detailed in this report supplements the Hearing Protocol for the Licensing Act 2003 and the Gambling Act 2005. This procedure is relevant where all parties to a Sub-Committee Hearing are in agreement about the preferred outcome. Appendix 1 sets out the process and requirements for the parties to request the Licensing Sub-Committee to determine the application without a formal licensing hearing taking place.

### RECOMMENDATIONS:

**That the Licensing Committee agree the procedure for dispensing with a formal Licensing Sub-Committee hearing, attached at Appendix 1.**

### SUPPORTING INFORMATION

Section 162(2) of the Gambling Act 2005 and Section 201(4)(a) of the Licensing Act 2003 permit an application to be determined by a Licensing Sub-Committee without a hearing taking place.

Regulation 9 of the Licensing Act 2003 (Hearings) Regulations 2005 and Regulation 12 of the Gambling Act 2005 (Proceedings of the Licensing Committees and Sub-Committees (Premises Licences and Provisional Statements) Regulations 2007 permit a Licensing Sub-Committee to dispense with holding a hearing if all relevant parties agree that a hearing is unnecessary, and give notice to the authority to that effect. The effect of this would be that the Sub-Committee would still meet to consider any objections or representations, but the parties would not attend, and the meeting would not need to take the form of a “hearing”.

On 15 October 2015 the Licensing Committee approved the Hearing Protocol for Licensing Sub-Committee meetings held under the Licensing Act 2003 and Gambling Act 2005.

Paragraph 9.3 of the Hearing protocol permits parties to apply to dispense with a hearing where all parties agree a hearing is unnecessary. Paragraph 9.3 can assist to speedily determine applications where all parties have agreed conditions and other matters such as periods of suspension related to the application in question.

Appendix 1 sets out the procedure to be followed where all parties to a hearing agree that a hearing is unnecessary and wish to request for the hearing to be dispensed with.

The proposal is for an officer of the Regulatory Services team to prepare a report for the Licensing Sub-Committee outlining the application and reasons why the parties believe it is not necessary to hold a formal Licensing Sub-Committee hearing. The Licensing Sub-Committee will then determine:

1. Whether or not to dispense with the hearing and give reasons for their decision; and
2. Where a hearing has been dispensed with, to determine the outcome of the application on the basis of the report prepared by the Regulatory Services officer.

Formally convened meetings are not required to consider applications to dispense with hearings. The meeting can take the form of a telephone conference, exchange of emails or an informal meeting. In most situations, it is likely that the agreement reached between the parties will then become the decision of the Licensing Sub-Committee.

The Licensing Sub-Committee retains the discretion to refuse the application to dispense with a hearing. Regardless of the outcome of the application, the Sub-Committee is required to provide written reasons for its decision.

Where a Licensing Sub-Committee refuses an application to dispense with a hearing, a Licensing Sub-Committee hearing will have to take place within 10 working days.

**PROCEDURE WHERE ALL PARTIES HAVE AGREED TO DISPENSE WITH A HEARING  
UNDER THE LICENSING ACT 2003 AND GAMBLING ACT 2005**

1. This procedure supplements Paragraph 9.3 of the Licensing Act 2003 and Gambling Act 2005 Hearing Protocol.
2. This procedure may be utilised by a Licensing Sub-Committee :
  - 2.1 Following the publication of a Licensing Sub-Committee Agenda; and
  - 2.2 Up to 24 hours before a Licensing Sub-Committee hearing is convened to determine an application brought under the Licensing Act 2003 and/or Gambling Act 2005; and
3. In order for this procedure to be utilised, all parties to the hearing should provide the licensing officer with correspondence confirming:
  - 3.1 The terms of any agreement reached with regard to a licensing application; and
  - 3.2 That they are of the opinion that a hearing can be dispensed with; and
  - 3.3 A request to grant the application on the terms agreed by all parties
4. The information contained in Paragraph 3 above will form the basis of an electronic report to the Licensing Sub-Committee and its legal advisor containing:
  - 4.1 A copy of the application;
  - 4.2 The relevant representations received;
  - 4.3 Copies of the correspondence referred to in Paragraph 3 above;
  - 4.4 A recommendation that the Sub-Committee (1) dispenses with the hearing and (2) determines the application on the basis of the information contained in the report.
5. When considering the abovementioned report and determining the application, the Sub-Committee do not have to formally meet. The Democratic Services team will ensure that the Sub-Committee are able to discuss the application with each other in order to reach a determination. The discussion may take place by holding an informal meeting, Skype connection, telephone conference or other suitable electronic/digital method of communication.
6. Democratic Services will ensure that Legal and Democratic Services officers are available to provide assistance as required
7. The Sub-Committee must:
  - 7.1 First decide whether they agree to dispense with a hearing; and
  - 7.2 Secondly, whether they agree to grant the application on the conditions agreed by the parties.
8. The matters referred to in Paragraph 7 do not have to be unanimously agreed.
9. If the Sub-Committee do not agree to any one of the matters referred to in Paragraph 7 above, a Sub-Committee must take place within 10 working days of the refusal of the application to dispense with a hearing. .

10. If the Sub-Committee agrees to the matters referred to in Paragraph 7 above, the Chairman should provide written confirmation of the decision to the Democratic Services team.
11. A decision notice will be prepared and sent to all parties in the usual way.



## GAMBLING ACT 2005 – UPDATE ON FIXED ODDS BETTING TERMINALS

### HEADLINE

The Government have reduced the maximum stake of Fixed Odd's Betting Terminals to £2 following a consultation.

### RECOMMENDATION

**That the Committee note the information**

### INFORMATION

The Government carried out a public consultation in January of this year to seek views on proposed changes to the limits on gaming machine maximum stakes.

The Cabinet Member for Community, Regeneration and Commerce responded on behalf of the Council and recommended that the maximum stake be cut to £2.

On 17<sup>th</sup> May, the Government announced that the limits would be cut to £2 and released the following statement;

*"When faced with the choice of halfway measures or doing everything we can to protect vulnerable people, we have chosen to take a stand. These machines are a social blight and prey on some of the most vulnerable in society, and we are determined to put a stop to it and build a fairer society for all. Problem gambling can devastate individuals' lives, families and communities. It is right that we take decisive action now to ensure a responsible gambling industry that protects the most vulnerable in our society. By reducing FOBT stakes to £2 we can help stop extreme losses by those who can least afford it. While we want a healthy gambling industry that contributes to the economy, we also need one that does all it can to protect players."*

The change is being made by the introduction of secondary legislation which has been reported could take a maximum of 2 years to introduce. Further updates will be provided when the legislative timetable is announced.

Hillingdon currently has 51 Betting Shops and each one has 4 FOBT's located within it, totalling 204 machines borough-wide.

Research has shown that there were more than 230,000 FOBT sessions which resulted in losses of more than £1000 and the average FOBT user losing £192 per month. Research also shows that 43% of FOBT users are problem or at-risk gamblers.

The Gambling Commission statistics show that Betting Shop operators make over half of their profits from FOBT's compared with over the counter bets. The industry has responded to the reduction in stake limits by announcing that up to half of Britain's betting shops will face closure resulting in approx 20,000 job losses.
