Part III of the London Local Authorities Act 1990 (as amended): Street Trading

Rules of Procedure for Urgent Licensing Sub-Committee Hearings

1. SCOPE

- 1.1 These procedure rules apply to Licensing Sub-Committees established by the Licensing Committee of Hillingdon Council acting as Licensing Authority. The rules are subject to Street Trading legislation as contained in Part III of the London Local Authorities Act 1990 (as amended)
- 1.3 The purpose of these procedure rules is to guide the Licensing Sub-Committees through the various stages of hearing urgent applications for street trading licences and to direct the sub-committee hearing a case, and all other parties involved, on the essential procedural requirements to be followed before, during and after a hearing.
- 1.4 Urgent applications to be determined in accordance with this procedure shall include but is not limited to:
 - a. Applications for charitable street trading;
 - b. Applications for street trading linked to community events, for example, fairs
 - c. Applications linked to Shop Front or Tables and Chairs Licences which seek to amend / vary the named Licence Holder;

- d. Applications for pitch licences which seek to amend / vary the assistants licensed to the pitch:
- e. Any other unopposed application which the relevant Council Officer considers to be urgent.

2. SUB-COMMITTEES

Role, Composition and Quorum

- 2.1 All hearings under these procedure rules will be conducted by licensing sub-committees for the sole purpose of determining urgent applications for and in relation to licences as required under Street Trading legislation as contained in Part III of the London Local Authorities Act 1990 (as amended) [the "Act"].
- 2.2 A sub-committee will usually consist of two members drawn from the Licensing Committee. The quorum for hearings and meetings of a sub-committee is two members. Each meeting shall be chaired by a designated Licensing Sub-Committee Chairman.
- 2.3 The Head of Democratic Services, or his representative (usually the Clerk to the Licensing Committee) shall appoint each sub-committee taking into account the need for it to be politically balanced, where possible; the need to involve all members of the Licensing Committee as equally as possible; the need to avoid involving members with an interest in the item to be discussed or members from the ward in which the subject premises is located; and the timescale available for determining applications.
- 2.3 Where hearings are convened using this procedure, Section 100A of the Local Government Act 1972 permits a Sub-Committee meeting to be convened with less than five clear days notice.

Power to adopt own Procedure

2.4 Except where otherwise prescribed by the Act, the sub-committee has wide powers to adopt its own procedures as to the general order and manner in which the hearing is to be conducted. For example, it may in any particular case dispense with or modify these Rules of Procedure.

3. BEFORE THE HEARING

Time Limits for Setting up Hearings

3.1 The Act does not prescribe a specific period of time within which an urgent hearing is to be held. It is expected that a hearing will to be commenced within 72 hours of Democratic Services receiving a report related to an unopposed application for a street trading licence / variation of a street trading licence from the relevant Council Officer

Notice Procedures

3.2 In order to hold a fair and transparent hearing, the relevant Council division and parties to proceedings are required to notify each other of relevant information in advance of the hearing as follows:

Notice of Hearing from the Licensing Authority

- 3.3 Notice shall given as soon as possible by Democratic Services to all parties to the hearing specifying the date, time and place at which the hearing is to be held.
- 3.4 The Notice of Hearing shall be accompanied by information in writing regarding the following:
 - (i) This procedure note, confirmation from the relevant Council Officer that the matter is unopposed and details of the application as provided by the relevant Council Officer.
 - (ii) Confirmation that a party may be assisted / represented by a person who does not have to be legally qualified;
 - (ii) The consequences if a party:
 - (a) Informs the sub-committee that he/she does not wish to attend or be represented at the hearing, or
 - (b) Fails to inform the relevant committee whether he/she wishes to attend or be represented at the hearing, or
 - (c) Informs the sub-committee that he/she wishes to attend or be represented at the hearing, but fails to attend or be represented.

(iii) the legal requirements imposed on the sub-committee in conducting the hearing.

Street Scene Enforcement Team Officer's Report

3.5 A report on the application to be determined will be presented at the hearing by the relevant Council Officer, which will contain a summary of the application, their technical observations and recommendations.

Consequences of failure to Attend Hearing

- 3.6 The sub-committee committee may proceed with a hearing in the absence of the Applicant.
- 3.7 Where the hearing is held in the absence of a party, the relevant committee shall consider at the hearing the application or objections made by that party.

4. THE HEARING

Principles to be applied

- 4.1 Subject to paragraph 4.2 and 4.3 below, the hearing shall take place in public.
- 4.2 The sub-committee may direct that all or part of a hearing must be held in private if it is satisfied that it is necessary in all the circumstances of the case, having had regard to:
 - (i) any unfairness to a party that is likely to result from hearing in public; and
 - (ii) the need to protect as far as possible, the commercial or other legitimate interests of a party.
- 4.3 Issues that involve personal details such as medical conditions or criminal records will normally be held in private session.
- 4.4 Changes to the membership of the sub-committee will be announced at the beginning of the hearing.

- 4.5 The hearing will take the form of a discussion led by the Chairman of the relevant committee. As the hearing is not a court:
 - (i) strict rules of evidence will not apply
 - (ii) comments and questions are to be directed through the sub-committee Chairman.
 - (iii) cross-examination will not be permitted unless the sub-committee considers that cross-examination is required for it to consider the representations or application.
 - (iv) information, discussion and address must be relevant to the Act.
- 4.6 The sub-committee will have regard to the common law rules of natural justice and the Human Rights Act 1998 when exercising its decision-making functions, with particular reference to Article 6 of the European Convention of Human Rights which provides that:
 - "...in the determination of civil rights and obligations, everyone is entitled to a fair and public hearing within a reasonable time by an independent and impartial tribunal established by law".
- 4.7 A party may be assisted or represented at the hearing by any person whether or not that person is legally qualified. For the avoidance of doubt, a party may be assisted or represented by their Ward Councillor. However, no member sitting on the relevant subcommittee hearing the case can represent any of the interested parties or applicant.

Procedure at the Hearing

- 4.8 The Chairman shall at the beginning of the hearing introduce the members of the sub-committee, invite the parties to identify themselves and then explain to the parties the procedure that the sub-committee intends to follow.
- 4.9 The relevant Council Officer will then be invited by the Chairman to present the relevant details of his/her report (referred to in paragraph 3.11 above), and any other information regarding any details relevant to the application or representations which may have come to light since the report was written. Alternatively, the Chairman may proceed directly to paragraph 4.10 below.
- 4.10 The Applicant (s) or their representatives will normally be invited to address the subcommittee.
- 4.11 Each party shall be entitled to:

- (i) address the sub-committee or call witnesses
- (ii) provide further information on, or explanation of, any matter on which the licensing authority has indicated that it would want further clarification under paragraph 3.7(vi) above.
- (iii) subject to paragraph 4.4(iv) above, question any other party or person representing a party on any matter that is relevant to the application, or representation made on the application, where in all the circumstances the subcommittee considers it is appropriate to do so.
- 4.12 The sub-committee will take into consideration documentary or other information in support of the application or objections produced by a party:
 - (i) before the hearing; or
 - (ii) at the hearing, with the consent of all other parties attending the hearing.
- 4.13 At any time during the hearing, parties may be asked questions upon their presentation or evidence by any member of the sub-committee.
- 4.14 The parties shall be entitled to make closing submissions and will normally be invited to do in the following order:
 - (i) Street Scene Enforcement Officer
 - (ii) Applicant
- 4.15 The sub-committee may require any person who in his/her opinion is behaving in a disruptive manner to leave the hearing and may refuse to permit that person to return or to return upon complying with such conditions as the relevant committee may specify. However, any such person will be allowed to submit any evidence in writing that they proposed to give orally, provided they do so before the end of the hearing.
- 4.16 At the conclusion of evidence and closing submissions, the sub-committee will adjourn into closed session in order to deliberate and reach a decision. During this process only the Legal Adviser and Committee Clerk will remain with them.
- 4.17 If, during its deliberations, the sub-committee considers that it is necessary for any person present at the hearing to provide further information or clarification on a particular point, the hearing may be re-convened to deal with that issue before reaching a decision.

Role of Legal Advisor

- 4.18 The sub-committee may seek advice or clarification of any procedural, technical or legal matter from the legal adviser at any time during the course of the hearing.
- 4.19 The legal adviser will provide the Sub-Committee with any advice it requires properly to perform its functions whether or not the Sub-Committee requested that advice, on:
 - (i) questions of law or of mixed fact and law;
 - (ii) matters of practice and procedure;
 - (iii) the range of options available to the Sub-Committee;
 - (iv) Relevant national guidance, policy or codes;
 - (v) Other issues relevant to the matter before the Sub-Committee;
 - (vi) The appropriate decision-making structure to be applied in any given case.
- 4.20 The legal adviser may ask questions of witnesses and the parties in order to clarify the evidence and any issues in the case. The legal adviser is under a duty to ensure that every case is conducted fairly.
- 4.21 The legal adviser will play no part in making findings of fact but may assist the Sub-Committee by reminding it of the evidence taken from his/her own or the committee clerk's notes.
- 4.22 The legal adviser will assist the Sub-Committee where appropriate as to the formulation of reasons and the recording of those reasons.

5. THE DECISION

Principles to be applied

5.1 Each application will be determined on its own merits and the sub-committee shall make its decision based upon the merits of the individual circumstances of each case and its considerations shall be restricted to the evidence placed before it (see paragraph 5.3 and 5.4 below on how evidence will be assessed);

5.2 All decisions reached by a sub-committee shall be supported by reasons and a summary of the relevant evidence supporting those reasons. All decisions reached by the sub-committee must comply with the Act.

Time Limit

- 5.3 The relevant sub-committee shall determine the application on the last day on which the hearing was held. So, if the hearing finishes on a Monday, the determination must occur on the same day.
- 5.4 A verbal decision is given to the public at the end of the hearing or at the end of the relevant agenda item.

6. AFTER THE HEARING

Notification of Decision

- 6.1 After the hearing, formal notice of the sub-committee's decision and related information, such as any conditions that may be imposed on the street trading licence, shall be communicated to all parties to the proceedings, in writing, within 5 working days of a verbal decision being given.
- 6.2 All decisions upon an urgent application shall further be published for viewing on the Council's official website.

SUMMARY

The Street Scene Enforcement Team has now processed the applications for the renewal of shop front street trading licences. Having considered the applications and documentation, the Street Scene Enforcement Team suggests that it would be appropriate to renew the shop front street trading licences of traders as tabulated in Annexure 1.

RECOMMENDATION

That the temporary shop front street trading licences of each reported trader identified in Annexure 1 be renewed for a period of 6 months

ALTERNATIVE OPTIONS

- Approve the renewal of the licences for a further time limited period of less than 6 months – time period to be specified by the Sub-Committee or;
- B. Refuse to approve the renewal of the licences

INFORMATION

- 1. Street trading activity within the London Borough of Hillingdon is regulated by the London Local Authorities Act 1990 (as amended).
- 2. The applications listed in Annexure 1 are for the renewal of shop-front street trading licences
- 3. The licences issued will be temporary licences lasting for six months from date of issue.
- 4. The Street Scene Enforcement Team has examined all documentation accompanying the applications, Copies of the relevant documentation supplied by each trader will be available to be viewed by Councillors at the Licensing Sub-Committee Hearing
- 5. The Street Scene Enforcement Team is satisfied that each application complies with the London Borough of Hillingdon's Street Trading Regulations and the legislation.
- 6. The Street Scene Enforcement Team confirms that it has no objection to the grant of the licence.
- 7. Street Scene Enforcement Team Officers confirm the proposed trading activities have sufficient space of two (2) metres on the pavement for pass and re-pass by pedestrians.

- 8. On 04/08/2010 correspondence was despatched to the relevant traders. They were advised by the Street Scene Enforcement Team by post of the date and time of the Sub-Committee meeting at which their application to renew their street trading licence would be considered. Copies of this correspondence will be available to be viewed by Councillors at the Licensing Sub-Committee Hearing.
- 9. The correspondence also advised the traders of their right to attend the hearing and make written or verbal representations at the hearing.
- 10. Additionally, the traders were advised via correspondence that the application would be decided in their absence in the event that Democratic Services were not notified of the trader's intention to attend and/or address the Sub-Committee.
- 11. In light of the traders' compliance with Street Trading Regulations, the Street Scene Enforcement Team is not aware of any reason to revoke the licence or issue a licence for a period of less than 6 months.

LEGAL COMMENTS

- 12. This report recommends that the street trading licences as attached at Annexure 1 be renewed in accordance with Section 25(1) of the London Local Authorities Act 1990 (as amended) ("the Act").
- 13. An application for the renewal of a street trading licence should be made not later than two months before the date on which the existing licence will cease to be valid. This time period may be shortened if the Local authority considers it reasonable to do so.
- 14. Section 25(4) of the Act specifies that a street trading licence may not be granted:
 - a. To a person under the age of 17 years;
 - To a company incorporated under the Companies Acts, an unincorporated association or a partnership except where such an application is made to carry on ice cream trading
 - c. In respect of an application for a street trading licence which, if granted, would authorise trading in a street which is not a licence street. An exception to this prohibition is where the application is for the grant of a temporary permit and the proposed trader has the permission of the owner of the land to carry out trading activities. In such a situation, the applicant is required to provide sufficient evidence of such permission to the Licensing Sub-Committee.
 - d. Where the goods that the trader proposes to trade in are prohibited or embargoed by a resolution passed in compliance with Section 24(1)(b) of the Act.
- 15. In accordance with Section 25(4)(b), a licence may not be granted unless the Sub-Committee are satisfied that there is enough space in the street for the applicant to engage in the trading activity without causing undue interference or inconvenience to persons or vehicular traffic using the street.
- 16. As at 26 February 2010, all public pavements immediately in front of any shop within the London Borough of Hillingdon has been designated as a licence street for the purposes of street trading under the Act.

Re: Street trading application for a continental market on 23-25 September 2010

I am writing to advise my views on the above application. Having looked at the content of the application and discussed the practicability of holding the market with relevant council officers I would highlight the following points.

- This application is for a three day specialist market that will generate additional interest in Uxbridge town centre. Street markets are identified by the Association of Town Centre Management and the Greater London Authority as generators of trade and interest from consumers which benefits the town as a whole.
- 2. The person co-ordinating the proposed market is Philippe Basset, who for some time has operated a French Market in Pinner and Harrow town centres approximately three times a year. Enquiries with Harrow council indicate that the public look forward to the market visiting. Providing the market is well managed and council officers have a good overview of critical factors then they add to the attraction of the town centres.
- Over the years I have been Town Centre Manager I have received many informat enquiries from members of the public asking if we can have a market in the high street.
- 4. The experience of the Farmers Market that operated on the Civic Centre forecourt a few years ago is that specialist markets attract new customers to the town. Most shoppers shop the whole town, not just part of it. An attractive market therefore benefits the whole town. The Farmers Market experience also showed the importance of locating markets in areas of high footfall. The site proposed in the application meets this requirement.
- Research indicates that enthusiasm to advertise a market can be a problem if illegal methods are used, by using fly posting, for example. In the management plan put forward by Mr Bassett he has stated that only legal advertising methods will be used.
- Sultable methods need to be identified for refuse disposal so a nuisance is not created. Potentially this can be coupled to the usual street cleansing regime that already exists.

- Vehicle movements when the market is setting up or breaking down need to be carefully supervised in order to protect the public.
- 8. A place needs to be Identified for the market trader's vehicles to be parked. There is a potential opportunity here for council officers to negotiate a rate with the applicants for them to utilise unused space in the council's business parking area in Grainges Yard or other suitable parking areas.
- 9. There is some concern from market traders in the local authority market that exists in the Mall Pavilions shopping centre. Some of these traders could perhaps be incorporated within future markets (if these were to happen) and if this was something that the Licensing Committee felt was desirable. Nevertheless, competition and enhanced choice are important factors that serve to drive up quality of products and customer service that will benefit the consumer. Innovation and evolution of the existing retail offer coupled with good customer service are key features which will provide sustainable businesses in our town centres and sustain consumer interest.
- 10. Markets are supported by planning policy. In Planning Policy Statement 4 (PPS4) the focus is clearly on promoting competitive town centres (through Policy EC4) and this includes a diversity of retailing including support for existing markets and the possible reintroduction or creation of new markets.

It can be seen there are pros and cons associated with the application, but the positives would seem to outweigh the negatives and a trial would hopefully allay some of the fears that have been raised in discussion with me by existing market traders and street traders. On balance I feel the Licensing Committee should consider granting the street trading licences for the period requested as it would offer the opportunity to examine the measures that officers have identified as being essential to allowing the market to operate. It would further offer the opportunity to assess whether specialist markets like the one proposed by the applicants are a way of enhancing the vitality of Uxbridge town centre in the future.

Information about the street trading application was provided to the Uxbridge Initiative town centre partnership Transport & Environment group on 11th August. The group members present wished it to be known that they supported the grant of a license.



Dear Mr Hickson,

Firstly I must stress that I find it difficult to compose a considered response to this proposal, as you have omitted to include an inventory of stalls to be taken into account. The following argument is therefore a general criticism of the concept of a generic continental market taking place in Uxbridge High Street. My main concerns are its potential negative impact on local trace and environment.

Ten years ago an Uxbridge council committee meeting agreed that it was not in the best interests of the town to allow the sale of food on the High Street. This was decided as a solution to the recognized problem of food-outlets operating in the town illegally. It was accepted at this time that if you give a licence to one you give licence to all and so to prevent rubbish, rats and arguments no licences would be given to food vendors and no foodstuffs are to be sold on the High Street. You state that the proposed continental market needs a street trading licence. If you allow a licence for this, you will open the floodgates for other food stalls.

I have heard it said that the continental market; "would bring people into the town". The last french market here did indeed bring a crowd, but it also brought resentment and trouble as although it increased footfall in the town, it did nothing to improve local trade. Money was spent in the town but did not go to our own shopkeepers and stall holders. With the economic climate as harsh as it is I believe that our local shopkeepers and our own council market should be genuinely considered and supported before we go about importing competition.

The Committee will be mindful of the one one Regulations which govern the issuing of Street Trading Licenses. I see that these include evidence of £214 Public Liability insurance. It is clear from the Regulations that it is not possible to License's Market Promoter or Operator but only individual traders. It will follow that any insurance must be in the name of the individual trader and any strengt to provide blander cover without reaming the individual trader will not suffice. Photographs must be provided together with a copy of a valid UK passport with proof of address and national insurance number. No provisions seem to cost for foreign national being able to apply. All food traders are to comply with the requirement for each and every worker to have completed an approved course of food hygiene training. Refliese disposal must be sindiarly approved and all this to be in place 2 months better the testing date. An empiry to the Reforement Team this week elicited the information that not all details were to band. Street traders who have worked in Untridge for very many years were compelled to meet every letter of these Regulations before the grass of their Licence. I am confident that the Committee will ensure that all Applications meet the same strict criteria.

I wish to Jean to the attention of the Committee a matter which I consider most serious. It is well known to experienced Council Officers involved in the Town Centre that I am responsible for many aspects of the Council's Town Market and have been for 40 years. They are also aware of the Council's ownership and interest in the Market and that Estates Management are responsible to Members. Despite this we were neither included in the Consultation process. It was only by afrance that I heard about the proposal. My ability to respond was then hampered by limitation of time and indeed the relevant Officers in your Estates Department were both on leave when I became deflect in the Application. Their apportunity to comment has been very severely impaired. It is not in my retait to investigate or speculate on how it came about that we were not on the list. However, I do ask the Committee to instruct the Officers to include us both in any future consultation.

Finally, it is self-evident that the members of this Association have spirit years investing in this community. We have siever neglected our responsibility to the Turantor to the Council. We now ask that you reject this Application and give your full support to the traders of your own Market who need your belo at a difficult time.

SUMMARY

The Street Scene Enforcement Team has now processed an application for the renewal of a street trading licence. Having considered the application and documentation, the Street Scene Enforcement Team suggests that it would be appropriate to revoke the licence of the trader as tabulated in Annexure 1.

RECOMMENDATION

That the Licensing Sub-Committee refuses to grant the street trading licences of the reported trader identified in Annexure 1

ALTERNATIVE OPTIONS

- A. Grant the Licence application or:
- B. Grant the Licence application but vary the conditions of the licence

INFORMATION

- 1. Street trading activity within the London Borough of Hillingdon is regulated by the London Local Authorities Act 1990 (as amended).
- 2. The trader listed in Annexure 1 are holders of a shop-front licence. The trader listed on the annexure has been issued with be temporary licences lasting for six months from date of issue.
- 3. The Street Scene Enforcement Team has received an application for the renewal of the licence as listed in Annexure 1.
- 4. The Street Scene Enforcement Team has examined all documentation accompanying the application. Copies of the relevant documentation for the trader will be available to be viewed by Councillors at the Licensing Sub-Committee Hearing.
- 5. The Street Scene Enforcement Team has found that the application submitted isincomplete as the relevant supporting documentation was not provided at the time of submitting this report to Democratic Services. The document outstanding is listed in Annexure 1.
- 6. The Street Scene Enforcement Team is therefore unable to comment on the eligibility of the trader to be awarded a street trading licence as applied for,
- 7. Section 28(1)(d) of the London Local Authorities Act 1990 (as amended) permits the Sub-Committee to revoke a street trading where the trader is, on account of misconduct or for any other sufficient reason unsuitable to hold a street trading licence.

- 8. The Street Scene Enforcement Team has served a notice of its preferred recommendation and notified the trader of a 21 day period within which to make any representations. The notice for the trader listed in Annexure 1 was sent on 2 August 2010.
- 9. On 18 August 2010 the relevant trader was advised by the Street Scene Enforcement Team by post of the date and time of the Sub-Committee meeting at which their application to renew their street trading licence would be considered, along with notification that a recommendation to revoke the licence will be made. Copies of this correspondence will be available to be viewed by Councillors at the Licensing Sub-Committee Hearing.
- 10. The correspondence also advised the trader of their right to attend the hearing and make written or verbal representations at the hearing.
- 11. Additionally, the trader was advised via correspondence that the application would be decided in their absence in the event that Democratic Services were not notified of the trader's intention to attend and/or address the Sub-Committee.

LEGAL COMMENTS

- 13. Section 31(1)() of the London Local Authorities Act 1990 (as amended) states that the Sub-Committee may, if they think fit, grant a temporary street trading licence to an applicant.
- 14. Regulation 3 of the London Borough of Hillingdon Street Trading Licence Terms and Conditions states that it is the Licensed Street Trader's responsibility to ensure that all documents requested for any application for a grant, renewal or variation of a licence is provided on applying for a Street Trading Licence.
- 14. Section 31 of the London Local Authorities Act 1990 (as amended) states that an applicant must satisfy the Sub-Committee of ownership of the land on which trading is proposed. Alternatively, where the applicant proposes to trade on land which is owned and/or occupied by another person, the applicant must satisfy the Sub-Committee that he/she has the relevant consent to trade on the land. If such consent is withdrawn after the issue of a licence, the temporary licence that was granted shall lapse.
- 15. Section 31(2) authorises the Sub-Committee to prescribe conditions which it deems necessary for the use of the licence.
- 16. Section 25(3A) requires that where third party insurance is a requirement for the issue of a licence, such insurance must be provided before the licence is granted.
- 17. Traders have given the licence holder not less than 21 days previous notice in writing that a refusal is proposed. This notice also specified the grounds on which the recommendation is based. Additionally, the applicant was notified of his/her right to appear before the sub-committee determining the matter.
- 15. Section 28 (2) of the Act states that the Council may instead of revoking a licence, vary it by attaching further specified conditions;
 - (a) reducing the numbers of days in any week or the period in any one day during which the licence holder is permitted to trade:
 - (b) specifying a different licence street or position or place at which the licence holder may trade; (c) restricting the items which licence holder is permitted to sell.
- 16. The applicant must be notified in writing of the decision of the Sub-Committee.
- 17. The Council has a duty in considering this matter to take account of all relevant considerations and disregard any matters of irrelevance. In doing so, it must have regard

SUMMARY

The Street Scene Enforcement Team has now processed an application for a street trading licence. Having considered the application and documentation, the Street Scene Enforcement Team suggests that it would be appropriate to issue the licence of the trader as tabulated in Annexure 1.

RECOMMENDATION

That the Licensing Sub-Committee refuses to grant the street trading licences of the reported trader identified in Annexure 1

ALTERNATIVE OPTIONS

- A. Grant the Licence application or:
- B. Grant the Licence application but vary the conditions of the licence

INFORMATION

- 1. Street trading activity within the London Borough of Hillingdon is regulated by the London Local Authorities Act 1990 (as amended).
- 2. The trader listed in Annexure 1 has applied for a shop-front licence. This is the first application received.
- 3. The Street Scene Enforcement Team has examined all documentation accompanying the application. Copies of the relevant documentation for the trader will be available to be viewed by Councillors at the Licensing Sub-Committee Hearing.
- 4. The Street Scene Enforcement Team has found that the application submitted is incomplete as the relevant supporting documentation was not provided at the time of submitting this report to Democratic Services. The document outstanding is listed in Annexure 1.
- 5. The Street Scene Enforcement Team is therefore unable to comment on the eligibility of the trader to be awarded a street trading licence as applied for.
- 6. The Street Scene Enforcement Team has served a notice of its preferred recommendation and notified the trader of a 21 day period within which to make any representations. The notice for the trader listed in Annexure 1 was sent on 10 August 2010.
- 7. On 1 September 2010 the relevant trader was advised by the Street Scene Enforcement Team by post of the date and time of the Sub-Committee meeting at which their application to renew their street trading licence would be considered, along with

- notification that a recommendation to revoke the licence will be made. Copies of this correspondence will be available to be viewed by Councillors at the Licensing Sub-Committee Hearing.
- 8. The correspondence also advised the trader of their right to attend the hearing and make written or verbal representations at the hearing.
- 9. Additionally, the trader was advised via correspondence that the application would be decided in their absence in the event that Democratic Services were not notified of the trader's intention to attend and/or address the Sub-Committee.

LEGAL COMMENTS

- 13. Section 31(1)() of the London Local Authorities Act 1990 (as amended) states that the Sub-Committee may, if they think fit, grant a temporary street trading licence to an applicant.
- 14. Regulation 3 of the London Borough of Hillingdon Street Trading Licence Terms and Conditions states that it is the Licensed Street Trader's responsibility to ensure that all documents requested for any application for a grant, renewal or variation of a licence is provided on applying for a Street Trading Licence.
- 14. Section 31 of the London Local Authorities Act 1990 (as amended) states that an applicant must satisfy the Sub-Committee of ownership of the land on which trading is proposed. Alternatively, where the applicant proposes to trade on land which is owned and/or occupied by another person, the applicant must satisfy the Sub-Committee that he/she has the relevant consent to trade on the land. If such consent is withdrawn after the issue of a licence, the temporary licence that was granted shall lapse.
- 15. Section 31(2) authorises the Sub-Committee to prescribe conditions which it deems necessary for the use of the licence.
- 16. Section 25(3A) requires that where third party insurance is a requirement for the issue of a licence, such insurance must be provided before the licence is granted.
- 17. Traders have given the licence holder not less than 21 days previous notice in writing that a refusal is proposed. This notice also specified the grounds on which the recommendation is based. Additionally, the applicant was notified of his/her right to appear before the sub-committee determining the matter.
- 15. Section 28 (2) of the Act states that the Council may instead of revoking a licence, vary it by attaching further specified conditions;
 - (a) reducing the numbers of days in any week or the period in any one day during which the licence holder is permitted to trade;
 - (b) specifying a different licence street or position or place at which the licence holder may trade; (c) restricting the items which licence holder is permitted to sell.
- 16. The applicant must be notified in writing of the decision of the Sub-Committee.
- 17. The Council has a duty in considering this matter to take account of all relevant considerations and disregard any matters of irrelevance. In doing so, it must have regard to the rules of natural justice. This is in addition to complying with procedural requirements set out in the statute.

SUMMARY

The Street Scene Enforcement Team has now processed the new applications for temporary shop front street trading licences *as tabulated in Annexure 1. Having considered the applications and documentation, the Street Scene Enforcement Team suggests that it would be appropriate to issue temporary pitch licences for the traders as tabulated in Annexure 1.

RECOMMENDATION

That temporary shop front street trading licences of the reported traders identified in Annexure 1 be issued for a period of 6 months.

- Approve the issue of the licences for a further time limited period of less than 6 months – time period to be specified by the Sub-Committee. or;
- B. Refuse to issue of temporary shop front street trading licence<<s>>.

INFORMATION

- 1. Street trading activity within the London Borough of Hillingdon is regulated by the London Local Authorities Act 1990 (as amended).
- 2. The applications listed in Annexure 1 are for new temporary shop front street trading licences
- 3. The licences issued will be temporary licences lasting for a period of 6 months.
- 4. The Street Scene Enforcement Team has examined all documentation accompanying the applications. Copies of the relevant documentation supplied by each trader will be available to be viewed by Councillors at the Licensing Sub-Committee Hearing.
- 5. The Street Scene Enforcement Team is satisfied that the applications complies with the London Borough of Hillingdon's Street Trading Regulations and the legislation,
- 6. The Street Scene Enforcement Team confirms that it has no objection to the grant of the licence.
- 7. Street Scene Enforcement Team Officers confirm the proposed trading activities have sufficient space of two (2) metres on the pavement for pass and re-pass by pedestrians.
- 8. On 10 August 2010 correspondence was despatched by mail to the relevant traders. The Street Scene Enforcement Team advised them by post of the date and time of the Sub-

- Committee meeting at which their application for their street trading licence would be considered. Copies of this correspondence will be available to be viewed by Councillors at the Licensing Sub-Committee Hearing.
- 9. The correspondence also advised the traders of their right to attend the hearing and make written or verbal representations at the hearing.
- 10. Additionally, the traders were advised via correspondence that the application<<s>> would be decided in their absence in the event that Democratic Services were not notified of the trader's intention to attend and/or address the Sub-Committee.
- 11. In light of the traders' compliance with Street Trading Regulations, the Street Scene Enforcement Team is not aware of any reason refuse the licences for the period requested.

LEGAL COMMENTS

- 12. This report recommends that the street trading licences as attached at Annexure 1 be renewed in accordance with Section 25(1) of the London Local Authorities Act 1990 (as amended) ("the Act").
- 13. An application for the renewal of a street trading licence should be made not later than two months before the date on which the existing licence will cease to be valid. This time period may be shortened if the Local authority considers it reasonable to do so.
- 14. Section 25(4) of the Act specifies that a street trading licence may not be granted:
 - a. To a person under the age of 17 years;
 - b. To a company incorporated under the Companies Acts, an unincorporated association or a partnership except where such an application is made to carry on ice cream trading
 - c. In respect of an application for a street trading licence which, if granted, would authorise trading in a street which is not a licence street. An exception to this prohibition is where the application is for the grant of a temporary permit and the proposed trader has the permission of the owner of the land to carry out trading activities. In such a situation, the applicant is required to provide sufficient evidence of such permission to the Licensing Sub-Committee.
 - d. Where the goods that the trader proposes to trade in are prohibited or embargoed by a resolution passed in compliance with Section 24(1)(b) of the Act.
- 15. In accordance with Section 25(4)(b), a licence may not be granted unless the Sub-Committee are satisfied that there is enough space in the street for the applicant to engage in the trading activity without causing undue interference or inconvenience to persons or vehicular traffic using the street.
- 16. As at 26 February 2010, all **Highway**" means a route or area which all persons can use to pass and repass along as often and whenever they wish without let or hindrance and without charge; this includes carriageway, footway and any part of that area where the public have access and which may be in public or private ownershippublic within the London Borough of Hillingdon designated for the purposes of street trading under the Act.
