| 69.  | <p><b>LAND EAST OF THE FORMER EMI SITE, 120 BLYTH ROAD, HAYES - 51588/APP/2015/1613</b> (<i>Agenda Item 6</i>)</p> <p><b>Minor amendments to design, external appearance and car parking layout through variation of condition 2 of Planning Consent reference 51588/APP/2011/2253 for the 'Demolition of warehouse extension to Apollo House and erection of a part 4, part 5, part 6 and part 7 storey building comprising 132 residential units, cafe (class A3), Community room (class D2), 5 x workshop units (class B1, B8 or a2 uses), and associated car parking and landscaping'.</b></p> <p>Officers introduced the report and provided an overview of the application.</p> <p>Officers explained that the variation of the condition would permit the approved plans to be altered so that minor revisions could be made to the proposal.
