HEADLINES

To enable the Committee to comment on the annual performance of the 2017/18 Safer Hillingdon Partnership Plan, and review the progress to date (up to quarter one where available) of the 2018/19 Plan.

RECOMMENDATIONS:

That the External Services Select Committee scrutinises performance of the Safer Hillingdon Partnership Plan 2017/18, and note the performance to date of the 2018/19 Plan.

SUPPORTING INFORMATION

In April 2009, councils were given new powers to scrutinise crime and disorder issues through provisions made in the Police and Justice Act 2006. The Crime and Disorder (Overview and Scrutiny) Regulations 2009 supplement the provisions made in section 19 of the Police and Justice Act regarding the operation of local authority crime and disorder overview and scrutiny committees in England and Wales. In particular, the Regulations make provision regarding the co-opting of additional members to that committee, the frequency of meetings, the provision of information to the committee, the attendance of officers and employees of responsible authorities and co-operating persons or bodies before the committee and the required response of responsible authorities and co-operating persons or bodies to recommendations made by the committee.

There is a requirement for every local authority to have a crime and disorder committee with the power to review and scrutinise, and make reports and recommendations regarding partnership activity and community safety issues in the local area. In Hillingdon, the External Services Select Committee fulfils this role and undertakes a bi-annual scrutiny of decisions made, or other action taken, in connection with the discharge by the responsible authorities of their crime and disorder functions.

The Crime and Disorder Act 1998 set out the statutory framework for responsible authorities to work with other local agencies and organisations to develop and implement strategies to tackle crime, disorder, misuse of drugs, anti-social behaviour and other behaviour adversely affecting the environment in their area. These statutory partnerships are known as Crime and Disorder Reduction Partnerships or Community Safety Partnerships

The Safer Hillingdon Partnership is this Borough's statutory Community Safety Partnership (under the Crime and Disorder Act 1998, the Police and Justice Act 2006 and Police and Crime Act 2009) and is part of the Hillingdon Local Strategic Partnership, Hillingdon Partners; and the Executive Group of the Hillingdon Local Resilience Forum.

The Safer Hillingdon Partnership comprises representatives at an executive level of the 'responsible authorities' (police, local authority, fire and rescue authority, health service, probation service), the elected Cabinet Member responsible for community safety at the Council, the Director of Public Health, a representative from the London Mayor's Office for Policing and Crime and the Chairman of Hillingdon's Safer Neighbourhood Board.

The Board meets every three months and is chaired by the Council Chief Executive and the Borough Commander alternately.

An annual strategic assessment of community safety trends and performance is undertaken. Arising from this assessment, the Board decides priorities for action which generate an annual action plan.
