	LSCB partners have adopted a new Missing Policy and practice guidance. This has now been embedded in practice since March 2018. Missing strategy meetings take place routinely and partners attend and contribute to ensure the needs of children who go missing are considered timely and in a multi agency forum. Training on CSE a Trauma focused approach is available for all
	professionals via LSCB and West London Alliance.
RECOMMENDATION 3 - Work with partner agencies to identify improvements in procedures to: a. prevent delays in relation to information sharing; and b. ensure that the Board of Governors safeguarding leads are included in relevant information sharing processes.	The newly formed Police West Area BCU consists of three Boroughs, Hillingdon, Ealing and Hounslow. CSE officers work across all three. This is already proving valuable in information sharing across locations frequented by young people. The continuation of proactive interventions, as seen in Operation Makesafe will continue across Hillingdon with locations to be targeted, already identified. The Child Protection Adviser for Education and LADO attend the Governors termly meetings by invite to share general practice updates and emerging child protection themes.
RECOMMENDATION 4 - Work with partner agencies to investigate the possibility of mapping CSE related resources across the Borough.	The successful intervention in safeguarding children from sexual exploitation is attributed to the co-location of specialist Child Sexual Exploitation Police Officers in MASH, to identify grooming and postcode gangs early through strategy meetings and escalation to MASE. A further success factor in early identification of group grooming and exploitation activity is through AXIS. This service is co-located in the Youth Offending Service. They work with young people who may not be receiving statutory services but have been identified as being on the periphery of risk by their own behaviour or through association. AXIS provide intervention and

support in collaboration with other services in order to reduce risk and prevent escalation. Key to their role is the intelligence mapping of youth activity across the borough. Health Partners assess and refer children attending Accident and Emergency, Minor Injury units and Early pregnancy units. The children are considered at weekly multidisciplinary meetings to ensure the right response to each child. Axis intelligence sharing ensures that lead professionals who know and or work with the children and young people in question, have a rounded understanding of risks and issues that they may not be fully aware of so they may provide appropriate intervention and support. The process also informs intervention for young people who may not be already known to agencies.
The Vulnerable Young People's Risk Management Group hears all cases of high risk vulnerability and works in collaboration with Axis to identify individuals and areas of concern on the Borough. Information is also shared with the Community Safety Team who are carrying out a number of community engagement events specifically targeting areas known for crime and antisocial behaviour. This is assisting us in starting to develop a local profile of the risks and associated vulnerabilities that our children and young people are experiencing. A Child Sexual Abuse, Emotional Wellbeing service starts in the Borough in the coming months and will provide therapeutic intervention for victims of abuse.
