# SUPPORTING INFORMATION

- 1. A petition was received containing 247 signatures requesting additional facilities for local residents at Brookside playing fields: footpaths around the park, football pitch, cricket pitch, tennis court and a running track, lighting and cameras each side of the Brookside Open Space.
- 2. Brookside Playing Fields is a large site in the middle of a built up part of the Borough. It is popular with many local residents for informal recreation, just before you enter the open space from Brookside Road there is an outdoor gym and children's playground. The site offers a tranquil area to walk around as well as cut through to the adjoining housing estate.
- 3. A draft Master Plan has been drawn up containing all of the requests of the petition (copy attached) with indicative costs in the region of £2.2m, to inform any future decisions.
- 4. The two items listed below have been entered onto the Chrysalis waiting list for 2019/20 for Brookside Open Space and are awaiting approval. This is in addition to the southern footpath that has already been installed using Chrysalis funding.

# 1. Construction of the northern section of footpath - £55,000

This will then link up with the two other sections that the Council is building on site this month. See attached site plan.

If/when the northern section is built, it will mean that the whole of the open space has a path all around the outside, this can also double up as a running/jogging circuit, as people can also use the central tarmac path to reduce the length that they want to run, or use it as a figure of 8.

# 2. Reinstatement of the old football pitch and cricket strip - £30,000

This will involve improving the current grass cutting regime to that for a football pitch and installing two new goals.

The cricket pitch would be an artificial grass strip on a stone base. The grass areas for the outfield would need to be improved and cut on a more regular basis than they are at present.

The exact location of these two pitches will need to be agreed on site with Green Spaces and the Community Group.

This is in addition to the two footpaths that have already been installed to the cost of £67k, and a further £102k spent on refurbishment of playground and installation of an outdoor gym.

## **Financial Implications**

In order to cater for all the requests of the petition, indicative costs of £2,200k have been estimated by the Council's Highways consultants. This would be a very expensive project and will not receive funding from Sports England as similar facilities have been provided in the neighbouring Borough which is a short distance away. If these requests are considered to proceed, then funding will have to be identified from a suitable funding source within the Medium Term Financial Forecast and would require a call on Council resources, increasing future capital financing revenue costs.

Works have already been carried out at Brookside Open Space in the past three years at a total cost of £169k on the central footpath, southern perimeter footpath, playground refurbishment and installation of outdoor gym from the Chrysalis Programme budget, funded through Council resources.

Subject to approval, there are a further two more schemes that could potentially proceed in 2019/20 from the Chrysalis Programme budget of £1,000k to construct a northern section perimeter footpath and reinstatement of the old football pitch and cricket wicket at a total estimated cost of £85k, all funded through Council resources. These schemes would not require additional maintenance costs as the Green Spaces team already maintains Brookside Open Space as part of its scheduled works and this cost is already incorporated in the current revenue budget.

Future improvements to Brookside Open Space, in addition to the above two schemes, could be considered within future years' Chrysalis funding beyond 2019/20, subject to Cabinet Member approval.
