To whom it may concern

I am writing to you with strong objections regarding the above public house [Sahara City]

Over many years residents in the vicinity of this establishment have been subjected to an array of anti social behaviour

Loud music being played from the venue either from inside the pub or the outside smoking/shisha area at unacceptable hours

Singing / screaming from customers while leaving the premises

Entertainment from live belly dancers

Concerns of under age drinking - this is extremely concerning as there are secondary schools close to this pub, surely there should be measures in place to ask youths there age , if no proof then no service

This pub advertises as a restaurant you can clearly see on line they cater for numerous customers there are many photos of tables and chairs on the pubs website however parking is extremely limited ,this has caused a massive amount of concerns to residents who live close to the public house ,the owner of this pub encourages his customers to park outside the pub causing obstructions to other road users ,the owner has been seen directing traffic in the evening waving a torch from the Uxbridge Rd [main rd] which is illegal

Smells of foods being cook is revolting - often in the evenings,weekends and during summer season the odours being extracted from this pub is awful

The owner has got a property close to the pub , I believe the cottage is called Coney cottage,by Coney green and uses this land as an overflow car park,again endangering the public due to poor management on his part

Does the deeds on this property allow him to use this front garden as an overflow car park for his business which is located at a different address ,it is a residential property,I would doubt he is allowed to do this

The owner repeatable uses a leaf blower to clear the pavements adjacent to the pub and blows pieces of rubbish onto the main road ignoring oncoming cars and members of the public walking along the pavements - this could endanger lives

Staff from this establishment empty large bins full of glass bottles into canisters in the pub car park at unacceptable hours [ie after the pub has closed]

I have concerns about crime and disorder - recently there was a massive brawl at this pub where a male was serious hurt - as a resident of this borough I am utterly disgusted this individual does NOT have working CCTV around his premises nor trained staff to deal with such measures - people have a right to be safe otherwise its only a matter of time before someone is killed

The owners of this pub have butchered this original locally listing building,they have not complied to planning regulations,ruined the look of the premises which stands in a conservation area

There is no consideration to the residents at all, how can he or any of his team provide any kind of trust to run a safe venue and allow members of the public to feel protected while in his pub

I do not believe Mr Abouzeid or his team should be given a new licence to run the Sahara city - in fact due to the amount of complaints from residents, interactions from the council and him not complying with planning I feel the only options left is to close this establishment down.
