HEADLINES

Summary

The Safeguarding Annual Report updates the Cabinet on the work undertaken by Hillingdon Safeguarding Partnership to support and safeguard Hillingdon's residents - children and adults.

The report focuses on work done by both the Safeguarding Children Partnership and the Safeguarding Adult Board and provide evidence about the standard to which the agencies responsible for safeguarding children and adults in the London Borough of Hillingdon have performed.

The chairmen of the respective boards state that the report provides assurance that the children and adults in Hillingdon are safeguarded and the response they receive from safeguarding partners optimise their safety, wellbeing and quality of life regardless of age.

The changes of safeguarding arrangements, in line with legislation, are presented in this report and show how they have strengthened the coordination between the Children and Adult Safeguarding Boards.

Policy Overview Committee comments

Members of the Social Care, Housing and Public Health Policy Overview Committee congratulated officers on their in-depth and focused report and were reassured to hear that the Partnership was working so successfully to safeguard all Hillingdon residents – both young and old.

The Committee noted that the report covered the previous financial year therefore did not focus on the Covid-19 period. However, Members were reassured to learn that, during the Covid-19 period, officers had continued to contact residents in need of support. Essential visits had continued and members of the public had still been able to make contact with the local authority in a number of ways.

The Policy Overview Committee noted that, at an operational level, the relevant agencies were committed and engaged and were attending meetings as required. It was confirmed that the attendance of police and health professionals, particularly at strategy meetings, was regularly monitored and reviewed.

The Members noted the criticism of previous safeguarding arrangements in the Serious Case Review regarding child X by Jane Wonnacott published in December 2019. They hope that all of the 16 recommendations in that report have been addressed.

SUPPORTING INFORMATION

- The Safeguarding Partnership Annual Report 2019/20 summarises the activity undertaken across the local partnership to meet the strategic objectives set by the Safeguarding Adult Board and Safeguarding Children Partnership.
- 2. In September 2019 the Hillingdon Safeguarding Partnership arrangements were launched in line with the statutory requirements set out in the Children and Social Work Act 2017 and Working Together to Safeguard Children 2018. The Local Authority now shares equal responsibility with our statutory partners, Hillingdon Clinical

Commissioning Group and Metropolitan Police, to safeguard children and young people.

- 3. The Care Act 2014 placed a statutory duty on each Safeguarding Adult Board to produce an Annual Report, outlining the work undertaken to achieve its strategic objectives, the work of each member to implement the Safeguarding Adults Board's strategy and detailing the findings of any Safeguarding Adult Reviews and subsequent required actions.
- 4. During 2019-20 Hillingdon Safeguarding Adult Board's structure was aligned with the Safeguarding Children's Arrangements. This enhanced collaborative working and our ability to optimise the safety, wellbeing and quality of life of all residents. Moreover, learning and development is now coordinated across the two Boards reducing duplication and strengthening our approach to practice improvement.
- 5. In promoting this joint approach, both boards are now scrutinised and held to account through the multiagency Executive Leadership Group. The group is chaired by the Local Authority's Chief Executive and attended by the senior representatives of the safeguarding partners (Police and Clinical Commissioning Group).
