| <i>Please tick;</i> | The NRA is objecting to the late hours requested in the application on the grounds of public nuisance as it will affect the residential properties close-by to the property. The nuisance will be from those either dining at the property or buying takeaway, particularly later on in the evening, on foot as well as by car and the latter will have a particular and unavoidable noise impact on those living close-by. |
| Prevention of Crime/Disorder | S14 -The premises are a restaurant and the NRA considers any alcohol sold should only be with a meal consumed on-site and not sold separately for consumption off-site even when purchased with a takeaway. All meals should be taken at a table and not at a bar. |
| Prevention of Public Nuisance | Alcohol should be delivered to tables only, by waiters and waitresses. |
| Protection of Children From Harm | The sale of alcohol separately or with a takeaway increases the likelihood of alcohol consumption in the local area, potentially in groups, not in the unit but potentially close by and that impacts the local residents. |
| Public Safety | S18 d) says they WILL play music that causes a nuisance to neighbours - either a typo, or needs clarity to ensure music is not heard outside the premises, even in the garden area, with adequate sound-proofing including two sets of doors at the entrance and the requirement to keep the windows closed. |

The outcome you are seeking from the Licensing Authority (See note 6);

No objection to the grant of an alcohol licence where consumed as part of the meal on-site at a table.

No alcohol to be sold before 12 noon or after 22:30 pm with the restaurant closing at 23:00 pm.

No customers to enter or re-enter the premises after 22:30 pm.

The restriction of the sale of alcohol to only as part of the meal, consumed on-site only, and not for sale for consumption off-site even with a takeaway, to retain the use of the premises as a restaurant and not a retail shop unit.

No alcohol to be consumed on the pavement outside the premises.

The Licence to have an end time of 23:00 pm, and if permission is granted for the sale of alcohol for consumption off-site then that element not before 12 noon nor after 10:00 pm so more restricted hours than for those using the premises as a restaurant.

Deliveries and emptying of glass goods to be between 09:00 am and 18:00 only.

No music to be heard outside the premises even through windows or doors when opened.

Notes:

All representations must be submitted before the conclusion of the 28 day consultation period. This will be advertised on the public notices and also on the Councils website.

Persons who may make representation include; persons who reside near to the premises to which the application relates and who are likely to be affected by licensable activities; residents associations who are representing residents who reside near to the application premises; Ward Councillors representing their constituents; any person who lives or works in the area and has concerns about the application premises.

Please note that representations cannot be anonymous. Copies of all representations will be published in any Committee papers and will be sent to all persons involved with the hearing including the applicant. If you have concerns about the use of your information and would like to discuss this further, please contact one of our Licensing Officers for a discussion, on the contact details below.

In order to be considered 'relevant', the representation must relate to one or more of the 'Licensing Objectives'. These objectives are;

Prevention of Crime/Disorder - This relates to any criminal activity, disorder or anti-social behaviour related to the application premises.

Prevention of Public Nuisance - This relates to noise nuisance and vibration, litter, noxious smells, light pollution.

Protection of Children from harm - This relates to the protection of children whilst on the application premises.

Public Safety - This relates to the physical condition of the premises and the safety features provided for members of the public such as; fire safety, health & safety.

Upon submitting a representation, it is expected that you will attend the Licensing Sub-Committee hearing to deliver your representation verbally and answer any queries that the Committee may have. If you are unable to attend, your written representation will be considered.

You may wish to suggest an outcome to the Licensing Sub-Committee ie. grant the application with extra conditions; grant the application with fewer hours/activities; reject the application. Please note that the Licensing Sub-Committee will only make reasonable and proportionate decisions based upon the evidence they are presented with, and in line with the laws and regulations governing Licensing Hearings.

You may continue on separate sheets of paper if necessary and you may also attach any evidence which supports your representation.
