# TITLE APPLICATION FOR TEMPORARY PITCH STREET TRADING LICENCE

## SUMMARY

The Street Scene Enforcement Team has now processed the new applications for temporary pitch street trading licences \*as tabulated in Annexure 1. Having considered the applications and documentation, the Street Scene Enforcement Team suggests that it would be appropriate to issue temporary pitch licences for the traders as tabulated in Annexure 1.

### RECOMMENDATION

Refuse to issue the licence temporary pitch street trading licences, as required documentation (listed in Annexure 2) and licence fees have not been supplied.

### ALTERNATIVE OPTIONS

A. That temporary pitch street trading licences of the reported traders identified in Annexure 1 be issued for three days being the 23+24+25 September 2010

#### INFORMATION

- 1. Street trading activity within the London Borough of Hillingdon is regulated by the London Local Authorities Act 1990 (as amended).
- 2. The applications listed in Annexure 1 are for new temporary pitch licences.
- 3. The licences, if issued will be temporary licences lasting for three days only being the 23+24+25 September 2010.
- 4. The Street Scene Enforcement Team has examined all documentation accompanying the applications; however the Sub-Committee should be aware that applicants have not supplied some of the supportive documents. Copies of the relevant documentation supplied by each trader will be available to be viewed by Councillors at the Licensing Sub-Committee Hearing.
- The Street Scene Enforcement Team consulted with local interested parties concerning these applications. This consultation was conducted between 16<sup>th</sup> August 2010 and 27<sup>th</sup> August 2010. A list of consultees are shown in Annexure 3 and responses received in Annexure 4
- 6. On 26<sup>th</sup> August 2010 correspondence was despatched by mail and by e.mail to the organising company Savoir Fayre who represent all applicants. The Street Scene Enforcement Team advised them by post of the date and time of the Sub-Committee meeting at which their application for their street trading licence would be considered.

Copies of this correspondence will be available to be viewed by Councillors at the Licensing Sub-Committee Hearing.

- 7. The correspondence also advised the traders and organising company Savoir Fayre of their right to attend the hearing and make written or verbal representations at the hearing.
- 8. Additionally, the traders organising company Savoir Fayre were advised via correspondence that the applications would be decided in their absence in the event that Democratic Services were not notified of the trader's intention to attend and/or address the Sub-Committee.

## LEGAL COMMENTS

- 9. This report recommends that the street trading licences as attached at Annexure 1 be renewed in accordance with Section 25(1) of the London Local Authorities Act 1990 (as amended) ("the Act").
- 10. An application for the renewal of a street trading licence should be made not later than two months before the date on which the existing licence will cease to be valid. This time period may be shortened if the Local authority considers it reasonable to do so.
- 11. Section 25(4) of the Act specifies that a street trading licence may not be granted:
  - a. To a person under the age of 17 years;
  - b. To a company incorporated under the Companies Acts, an unincorporated association or a partnership except where such an application is made to carry on ice cream trading
  - c. In respect of an application for a street trading licence which, if granted, would authorise trading in a street which is not a licence street. An exception to this prohibition is where the application is for the grant of a temporary permit and the proposed trader has the permission of the owner of the land to carry out trading activities. In such a situation, the applicant is required to provide sufficient evidence of such permission to the Licensing Sub-Committee.
  - d. Where the goods that the trader proposes to trade in are prohibited or embargoed by a resolution passed in compliance with Section 24(1)(b) of the Act.
- 12. In accordance with Section 25(4)(b), a licence may not be granted unless the Sub-Committee are satisfied that there is enough space in the street for the applicant to engage in the trading activity without causing undue interference or inconvenience to persons or vehicular traffic using the street.
- 13. As at 26 February 2010, all **Highway**" means a route or area which all persons can use to pass and repass along as often and whenever they wish without let or hindrance and without charge; this includes carriageway, footway and any part of that area where the public have access and which may be in public or private ownershippublic within the London Borough of Hillingdon designated for the purposes of street trading under the Act.

#### Re: Street trading application for a continental market on 23-25 September 2010

I am writing to advise my views on the above application. Having looked at the content of the application and discussed the practicability of holding the market with relevant council officers I would highlight the following points.

- This application is for a three day specialist market that will generate additional interest in Uxbridge town centre. Street markets are identified by the Association of Town Centre Management and the Greater London Authority as generators of trade and interest from consumers which benefits the town as a whole.
- 2. The person co-ordinating the proposed market is Philippe Basset, who for some time has operated a French Market in Pinner and Harrow town centres approximately three times a year. Enquiries with Harrow council indicate that the public look forward to the market visiting. Providing the market is well managed and council officers have a good overview of critical factors then they add to the attraction of the town centres.
- Over the years I have been Town Centre Manager I have received many informat enquiries from members of the public asking If we can have a market in the high street.
- 4. The experience of the Farmers Market that operated on the Clvic Centre forecourt a few years ago is that specialist markets attract new customers to the town. Most shoppers shop the whole town, not just part of it. An attractive market therefore benefits the whole town. The Farmers Market experience also showed the importance of locating markets in areas of high footfall. The site proposed in the application meets this requirement.
- 5. Research indicates that enthusiasm to advertise a market can be a problem if illegal methods are used, by using fly posting, for example. In the management plan put forward by Mr Bassett he has stated that only legal advertising methods will be used.
- Sultable methods need to be identified for refuse disposal so a nuisance is not created. Potentially this can be coupled to the usual street cleansing regime that already exists.

- Vehicle movements when the market is setting up or breaking down need to be carefully supervised in order to protect the public.
- 8. A place needs to be identified for the market trader's vehicles to be parked. There is a potential opportunity here for council officers to negotiate a rate with the applicants for them to utilise unused space in the council's business parking area in Grainges Yard or other suitable parking areas.
- 9. There is some concern from market traders in the local authority market that exists in the Mall Pavilions shopping centre. Some of linese traders could perhaps be incorporated within future markets (if these were to happen) and if this was something that the Licensing Committee felt was desirable. Nevertheless, competition and enhanced choice are important factors that serve to drive up quality of products and customer service that will benefit the consumer. Innovation and evolution of the existing retail offer coupled with good customer service are key features which will provide sustainable businesses in our town centres and sustain consumer interest.
- 10. Markets are supported by planning policy. In Planning Policy Statement 4 (PPS4) the focus is clearly on promoting competitive town centres (through Policy EC4) and this includes a diversity of retailing including support for existing markets and the possible reintroduction or creation of new markets.

It can be seen there are pros and cons associated with the application, but the positives would seem to outweigh the negatives and a triat would hopefully allay some of the fears that have been raised in discussion with me by existing market traders and street traders. On balance I feel the Licensing Committee should consider granting the street trading licences for the period requested as it would offer the opportunity to examine the measures that officers have identified as being essential to allowing the market to operate. If would further offer the opportunity to assess whether specialist markets like the one proposed by the applicants are a way of enhancing the vitality of Uxbridge town centre in the future.

Information about the street trading application was provided to the Uxbridge Initiative town centre partnership Transport & Environment group on 11<sup>th</sup> August. The group members present wished it to be known that they supported the grant of a license.

Firstly I must stress that I find it difficult to compose a considered response to this proposal, as you have omitted to include an inventory of stalls to be taken into account. The following argument is therefore a general criticism of the concept of a generic continental market taking place in Uxbridge High Street. My main concerns are its potential negative impact on local trace and environment.

Ten years ago an Uxbridge council committee meeting agreed that it was not in the best interests of the town to allow the sale of food on the High Street. This was decided as a solution to the recognized problem of food-outlets operating in the town illegally. It was accepted at this time that if you give a licence to one you give licence to all and so to prevent rubbish, rats and arguments no licences would be given to food vendors and no foodstuffs are to be sold on the High Street. You state that the proposed continental market needs a street trading licence. If you allow a licence for this, you will open the floodgates for other food stalls.

I have heard it said that the continental market; "would bring people into the town". The last french market here did indeed bring a crowd, but it also brought resentment and trouble as although it increased footfall in the town, it did nothing to improve local trade. Money was spent in the town but did not go to our own shopkeepers and stall holders. With the economic climate as harsh as it is I believe that our local shopkeepers and our cwn council market should be genuinely considered and supported before we go about importing competition.
