4.1	Provide more details on how Hillingdon are monitoring flood risk to make decisions on future projects.	Action A5 ensures that the Council keeps flood risk data up to date. The Environment Agency mapping on fluvial flood risk also reflects flood events as does the Council's own strategic flood risk assessment.	No changes. Observation noted.
4.3	Responses observed that Court Park, Elephant Park and Bessingby Parks flood alleviation schemes were not accompanied by consultation, have not been maintained and queries about their rationale were raised.	Engagement was undertaken on all these projects and positive feedback has been received about the efficacy of both Elephant Park and Bessingby Park. Concerns about Court Park are being investigated further.  Notwithstanding the above, strengthening engagement on projects has been identified through lessons learned and this will resolve matters relating to rationale. The Council will not undertake work whether it is not necessary. In some instances, the flood alleviation schemes protect residents that are downstream and away from the physical works.	Lessons learned for future project management are being implemented.
