275	West London Temporary to Permanent Housing Scheme	The West London Temporary to Permanent housing scheme is an innovative scheme to capture the value of rental payments on temporary accommodation to secure permanent affordable homes. The scheme will provide good quality temporary accommodation that will be converted at the end of the lease period into permanent affordable housing. This scheme was approved by Cabinet on the 20th March 2008, but on the 22nd April 2008 a High Court Judgement in the case of R.v. London Borough of Brent ex Parte Risk Management Partners Ltd has raised some legal questions on schemes that have joint arrangements and share financial liabilities. Counsel have advised that Local Authorities should seek Cabinet approval where the primary reliance is Section 2 of the Local Government Act 2000, the well being power.
